**Reasons:**

Community Safety is one of the Council's key priorities as set in Building a Better Bromley. In addition, the vision of the Public Protection and Safety Portfolio Plan is to make Bromley a place where crime and anti-social behaviour is significantly reduced and people feel safe and that the harm caused by drugs and alcohol to individuals, families and communities is reduced. Ensuring that people feel safe in Bromley remains a high priority both for the Portfolio and the Safer Bromley Partnership. There has been a significant focus both nationally and locally on the impact of young people drinking to excess and causing a nuisance. In particular 'under-age' alcohol consumption is of considerable concern. The declaration of the proposed Designated Public Place Order would contribute towards meeting these strategic priorities.
