Decision:

The site should be retained for future marketing for general needs housing once the market for residential development sites has improved.

Reasons:

Following refusal on appeal of a planning application for a foyer scheme, and subsequent termination of the sale agreement, the Council needed to decide what to do with this site. The options were whether to proceed with a sale at a revised price to secure a reduced scheme involving a foyer, or to retain the site for future marketing for general needs housing when the market recovered.

In view of the Council's duty to obtain the best price in disposing of land, and the wider considerations of the Bromley Town Centre Area Action Plan, the property should be retained in accordance with the Resources Portfolio Plan aim that Bromley should be a Council which manages its assets well.

The proposed decision was scrutinised by the Executive and Resources PDS Committee on 10th June 2009 (Minute 31) and the Committee supported the proposal, also referring to the implications of the Bromley Town Centre Area Action Plan as a reason to retain the property.
