#### 1. Responsibility of the governing body where a school is underperforming

- 1.1 The governing body is responsible for raising standards through its three key roles of setting strategic direction, ensuring accountability, and monitoring and evaluating school performance. The governing body of a school is accountable to the local authority for the way the school is run (**The Governors' Guide to the Law**, section 4 para: 23).
- 1.2 The local authority would support a school's efforts to achieve continuous improvement and would expect to work in partnership with the governing body to achieve this aim, but the accountability remains with the governing body and its headteacher.
- 1.3 There is statutory guidance for local authorities where a school is causing concern. Where a school is causing concern, or a governing body is acting in a way that is detrimental to the performance of pupils at the school, the local authority can use its powers to intervene to ensure a school can raise standards. This includes adding additional governors, or even discharging a governing body in its entirety and replacing it with an interim executive board.

#### 2. Underperformance based on pupil progress

- 2.1 Some schools may have a pupil profile of above average attainment in national test results at the end of Key Stage 2, but the progress those pupils make from Key Stage 1 to Key Stage 2 is average or below average when compared nationally. The Department for Children, Schools and Families (DCSF) previously used the term 'coasting' to describe such schools.
- 2.2 Generally, these types of schools are found in more affluent areas where home circumstances have prepared pupils' well for school so that children attain above average results at Key Stage 1, but where teaching from Key Stage 1 to Key Stage 2 has been inconsistent in quality, teacher expectations have not been high enough or where other circumstances such as staff mobility have impacted on pupil progress in learning.
- 2.3 The term 'coasting' is no longer used by the Department for Education (DfE). However, pupil progress from Key Stage 1 to Key Stage 2 is still used to judge the added value a school contributes to pupils' learning.

- 2.4 When determining the level of support to be given to schools in Bromley, the local authority considers pupil progress results over a three year period compared to standards at a school. There are no schools currently where progress has not matched attainment over a three year period from 2009 to 2012. However progress measures are monitored by the Head of Learning and Achievement and, if a school was in these circumstances, it would receive additional support for ensuring all pupil groups have opportunities to make good progress from Key Stage 1 to Key Stage 2.
- 2.5 Ofsted would also take pupil progress into consideration when inspecting a school, so that a school attaining high standards but not achieving good pupil progress measures could well be placed in a category of 'requiring improvement'.

- 5. Comment on successful intervention strategies
- 5.1 Local authorities such as Tower Hamlets have had a number of successful intervention strategies that have been well funded by government grants to secure school improvement in the past.
- 5.2 However, funding is not the sole solution to improving schools, and funding needs to be used to support robust school improvement strategies. Some other examples of where local authorities have had successes with school improvement are:
  - in areas where the professional 'talent pool' is high e.g. Richmond upon Thames is served by two local Universities and has good links with both for NQTs recruitment and higher level qualifications for teaching staff and school leaders;
  - where local authorities have worked intensively with the Department on regional or national initiatives to improve school performance e.g. the 'London Challenge' programme;
  - where local authorities have a clear and robust strategy for school improvement that is supported by Members, that is clear and transparent to schools, and that is consistently delivered by the local authority.
- 5.3 With the restructure of Education and Care Services, with changes to senior LA personnel and with the changing role of the local authority, it seems timely now to review our current practice for categorisation and support of Bromley schools. Officers would recommend a further report to be presented by the Assistant Director Education to the Education Policy Development and Scrutiny Committee in spring 2013 on 'Categorisation, intervention and support for high priority schools in Bromley'.
