## **Description of Development:**

Erection of canopy

## **Proposal**

The proposed structure will be situated at the rear of the school buildings and toward the western side of the site, 3.5m away from the western site boundary. It will occupy an existing tarmacked area and measure approximately 6m x 10m in area. The canopy will be supported by six posts and rise to a maximum height of approximately 3.3m.

A supporting letter accompanying the application advises that at present the school has no covered outdoor space which violates the Government's "criteria for schools to provide an indoor/outdoor teaching environment/area" and, furthermore, that this goes against "Health & Safety" provisions.

## **Location**

The site is situated along the northern side of Mead Road within what is a predominantly residential area. The site falls within the Chislehurst Conservation Area.

## **Comments from Local Residents**

No comments were received from local residents at the time that this report was compiled.

## Comments from Consultees

No technical objections have been raised.

## Planning Considerations

Relevant Unitary Development Plan Policies are BE1 (Design of New Development) and BE11 (Conservation Areas).

## Planning History

There is no planning history relevant to this application.

## Conclusions

The main issues relating to the application are the effect that it would have on the character and appearance of the Chislehurst Conservation Area and the impact that it would have on the amenities of the occupants of surrounding residential properties.

Although the proposed structure will occupy a sizeable area, the space will remain largely open and will be accessible from the surrounding playing areas. It will, to a large extent, be screened from the adjacent property by trees and hedges straddling the western site boundary. Accordingly, it is not considered that the character and appearance of the surrounding area will be significantly affected.

Having had regard to the above it was considered that the development in the manner proposed is acceptable in that it would not result in a significant loss of amenity to local residents nor impact detrimentally on the character of the Conservation Area.

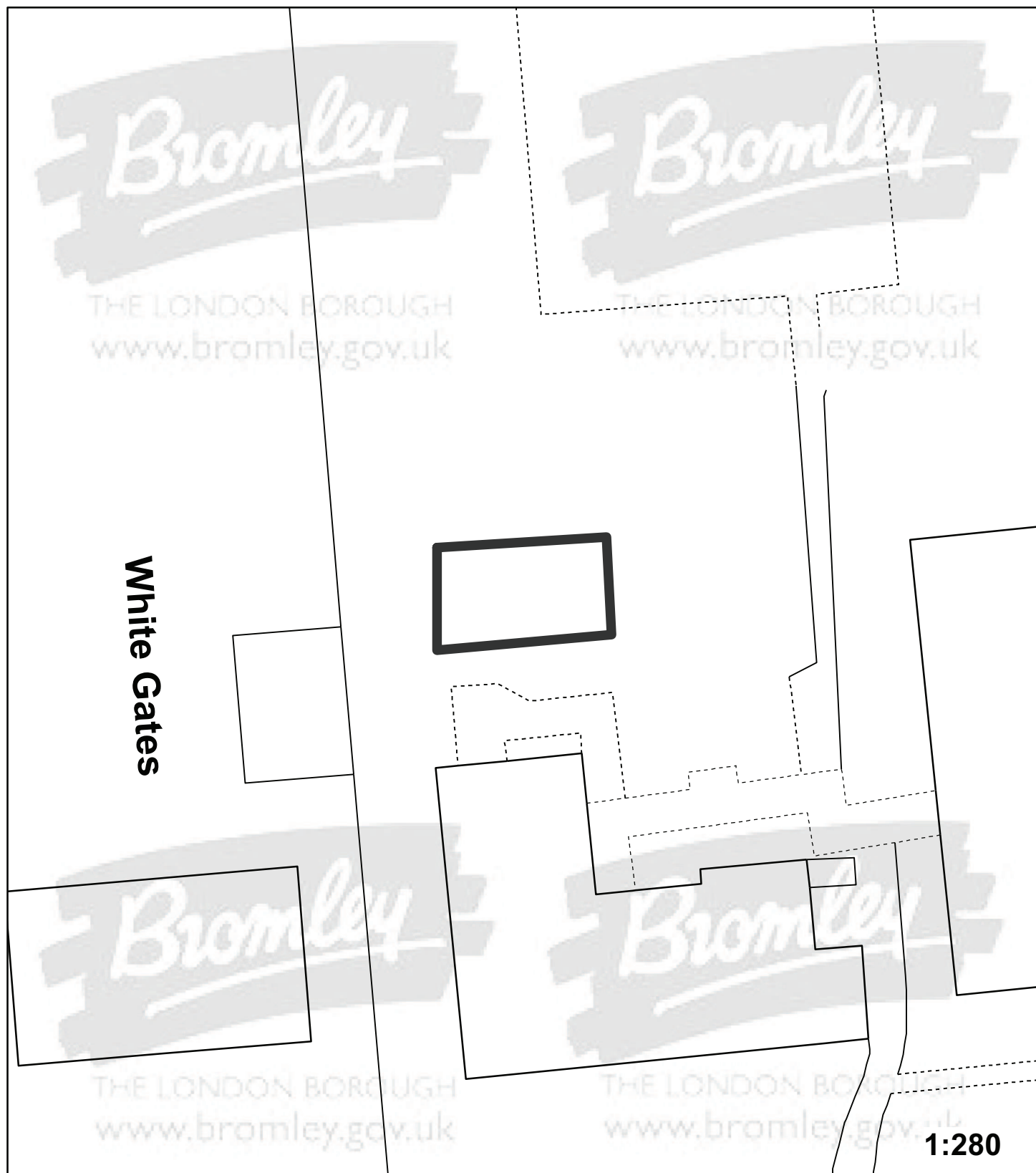
