The schedule of proposed proportionality, committee membership and appointment of chairmen and vice-chairmen (Appendix A) is attached.

Since the report was published, the following updates to the information in paragraphs 3.4 and 3.5 are necessary -

The size of each group is as follows –

Conservative – 35 seats (60.3%) Labour – 12 seats (20.7%) Liberal Democrat – 5 seats (8.6%) Chislehurst Matters – 3 seats (5.2%) Biggin Hill Independents – 2 seats (3.5%)

There is now only one independent, Cllr Jonathan Laidlaw, with Cllr Shaun Slator having been re-admitted to the Conservative group.

It is proposed that there are 174 seats to be allocated on committees and sub-committees, which gives a representation of exactly three seats per Member for each group, allowing for the Independent Councillor to also have three committee seats.
