3. COMMENTARY

- 3.1 On Saturday 6th May HM King Charles III will be crowned alongside The Queen Consort. Monday 8th May has been announced as a bank holiday to mark this occasion.
- 3.2 To celebrate the coronation in Bromley the borough will enable the following activities set out in this report. The Portfolio Holder for Resources, Commissioning and Contract Management has agreed £50k from the Community Fund will be made available to deliver this activity. Officers will also seek sponsorship opportunities.

Public screening of the Coronation

- 3.3 The Coronation will be screened live in Queen's Gardens, Bromley, on Saturday 6th May. The screening will be accompanied by intergenerational creative activities for families.
- 3.4 The cost of this is estimated at £20k. This cost is primarily made up of the screen hire and technical experts on site, the generator, and the undertaking of event management including the health and safety requirements for a large public event in the town centre.

Decoration of Bromley, Orpington, Beckenham and Penge High Streets

3.5 Funding of £5k will be granted to each of the borough's Business Improvement Districts to contribute towards the cost of decorating these four town centres over the celebratory period. This will support businesses by increasing footfall, and will complement any wider programming the BIDs are undertaking over the Coronation weekend.

Best decorated shop

3.6 A best decorated shop competition will be managed by the Culture and Regeneration division at a cost of £1k. Businesses across the borough will be invited to decorate their window displays to celebrate the Coronation, and submit photos. A judging panel will decide on the winning display and the Mayor of Bromley will award a prize.

Community celebration fund

3.7 Community groups will be able to apply for grants of up to £500 to support the costs of holding street parties or other commemorative events during the weekend of 6th – 8th May. The grants can support logistical, catering and other relevant costs. The total funding pot available is £9k and smaller requests for money will be prioritised so that as many groups as possible are supported.

Road closures for street parties

3.8 The Council will waive fees for road closures to hold street parties over the weekend of 6th – 8th May, providing applications are made by Monday 13th February 2023 to enable the Council to advertise the necessary legal notices.

4. IMPACT ON VULNERABLE ADULTS AND CHILDREN

4.1 The coronation activities will have no direct costs to individuals. The screening will be free to attend.

5. FINANCIAL IMPLICATIONS

5.1 There is sufficient funding available within the Community Fund to meet this expenditure, colleagues will need to raise the relevant purchase orders contained within this document on their own cost centres and request a transfer of funds from the community pot via

corporate finance. If expenditure exceeds the £50k set out in this report then a further approval would need to be sought from the Portfolio Holder.

6.1 The Council may rely on the power of competence under the Localism Act 2011 to carry out the activities described in this report.

7. PROCUREMENT IMPLICATIONS
