	Trading Standards had been undertaking sweeps of businesses to see if they were selling vapes to young people. It was noted that illegal vapes had been seized and the Board were reminded of the harmful amount of lead in vapes that could adversely affect brain development. As it stood, vapes could be legally given to young people free of charge if classified as a gift. Central Government was setting up a task force to look into problems concerning vapes and £3m was being allocated for this.	
	It was noted that a major concern in secondary schools currently was vaping. Public Health had developed a video along with the Council to highlight the dangers of vapes. This video was aimed primarily at parents and carers. It was agreed that the link to the video would be shared with the Board. The dangers of nitrous oxide usage was also discussed. The Chairman said that these discussions would have a bearing on what could be monitored in the new SBP Strategy. Consideration would need to be applied as to how relevant data could be monitored. The Chairman felt it would be helpful if fresh cascading could be undertaken each quarter.	FoD

	An update was provided by the Service Manager for Bromley Drug and Alcohol Service concerning an opioid reversal drug. The drug was called Naloxone. (<u>Note on Naloxone</u> : Naloxone, sold under the brand name Narcan among others, is a medication used to reverse or reduce the effects of opioids. It is used to counter decreased breathing in opioid overdose. Effects begin within two minutes when given intravenously, and within five minutes when injected into a muscle. The medicine can also be administered by spraying it into a person's nose. Emergency medical services data from Massachusetts found that 93.5% of people given naloxone survived their overdose.) The Bromley Drug and Alcohol Service Manager said that she had sourced some information from the Mayor of London's website that indicated that the police were not trained in the use of the drug, but that supplies were normally kept in police custody suites. Bromley Drug and Alcohol Service Manager was aware) and so the Service Manager was unclear where the police supplies would have originated from (if they had stocks in their custody suites). It had to be noted that the shelf life of the drug was two years, so existing stocks may need replacing.	

The Bromley Drug and Alcohol Service Manager explained that the drug would keep someone alive for about 20 minutes, which would hopefully be enough time for the person to receive lifesaving medical intervention. If the overdose was not opioid related, then administration of the drug would not have any adverse effects. The drug was also available in a nasal spray form called Nyxoid. The drug could not be provided to a stakeholder to provide to a service user, as the training would be diluted. Service users would need to approach BDAS directly. Training could be provided on the use of the injection from the age of 14, and from 8 for the nasal spray.	
The Service Manager stated that the Mayor of London website recommended that the police stock a minimum of three injections for custody suites. She wanted to check if Bromley Police had supplies and also if they required training. The LBB Domestic Abuse Strategic Lead Officer, suggested that it would be helpful for the Service Manager from Bromley Drug and Alcohol Service to brief the 'Operational Forum' and she agreed to do so.	
Superintendent Luke Baldock said that he would need to check the situation regarding police custody suites, as there was now a separate operational command for this area. The Service Manager for Bromley Drug and Alcohol Service agreed to provide the Board with a briefing concerning Naloxone, so that Board Members could use and disseminate this information as they deemed appropriate. Mr Sibun said that he would be happy to work with health colleagues to disseminate the information into the health care system. Fiona O Driscoll said that she would also be happy to do like-wise for Public Health. There was a discussion also as to how the information could be promoted to retail outlets, perhaps involving the BIDS. It was agreed that a new constitution and TOR were required. These would be disseminated with the minutes and comments were welcomed.	LB FoD LW/SW

Community Accommodation Service

A brief overview of accommodation services – Probation Service

What is CAS 3: Aims and Objectives

•Aim: The aim of the CAS3 service is to ensure that no one leaves prison without the offer of a place to live, from their first night in the community, and to provide a pathway to settled accommodation.

•Objectives: The key objectives of the CAS3 service are:

 To ensure that all prison leavers who would otherwise be homeless have access to temporary accommodation for up to 84 days on release or when moving on from CAS1 (Approved Premises) and CAS2 (BASS) provision.

To support prison leavers to move-on to settled accommodation at three months. This provision will provide a critical stabilising

This provision will provide a critical stabilising
 environment for people on release from prison from
 which they can address other aspects of their behaviour
 linked to their risk of re-offending.



The Accommodation

Must be available on the Prison Leavers' day of release.

- Must be available for up to 84 nights, although the assumption is that the individual may move on earlier.
- Accommodation from 1-bedroom self-contained units, to a maximum of 4 bed spaces with shared facilities.
- All single gender accommodation, 10% dedicated for sole use by females.
- Accommodation furnished to a serviceable standard/holiday let ready, with a welcome pack of basic food essentials and toiletries.
- The supplier must meet the prison leaver at the property on the day of release for property induction.

A phased increase to a maximum of just over 300 units is currently underway, having commenced in May 2023

Chief the service of the contract award to Housing Action Management (HAM) for the London Region



Who is Eligible?

•The scheme is open to adult prison leavers of all genders who are aged 18 or over and who are:

- At risk of being released as homeless from prison following a custodial sentence to be supervised by the Probation Service; or
- moving-on as homeless from an Approved Premises (CAS1); or
- moving on as homeless following a period at a CAS2 residence.

And who have;

- $\overset{\Phi}{\overset{N}{\sim}}$ given consent to be referred into the service; and
- signed an Accommodation Compact

CAS 3 is not available to:

- Persons on probation subject to a Community Order or Suspended Sentence Order only.
- Persons who are released after a period on remand, not under the supervision of the probation service as HMPPS have no statutory responsibility.
- Persons on probation subject to NRPF will not be eligible for CAS3
- Prison leavers who after their release, later become homeless.
- Prison leavers at the point of release on Home Detention Curfew.
- Persons released from custody at Sentence Expiry date (SED).
- Prison leavers where consent has been refused and/or/ there is a refusal to sign an Accommodation Compact.

Commissioned Rehabilitative Services (CRS)

CRS providers work closely with probation practitioners and community interventions teams to ensure the best outcomes are achieved for people subject to a Community Order or Suspended Sentence Order with Rehabilitation Activity Requirements (RAR) and on Licence or Post Sentence Supervision.

CRS providers are commissioned by Regional Probation Directors to deliver the following services:

- Accommodation pre-release and in the community
- Employment, training and education
- Personal wellbeing Finance, benefit an
 - Finance, benefit and debt
 - Dependency and recovery
 - Women's Services -provide all of the above as part of a holistic approach to service delivery

- In London the accommodation support service is commissioned to St Mungos / SHP
- There are no accommodation units attached to this provision with the service being solely focused on advice, guidance and signposting

Resettlement Panels

- As to ensure a coordinated response to information sharing around prison leavers, between Probation Services and LA Housing, the London Probation region have implemented resettlement panels
- These panels sit once a month and are chaired by Probation
- The panels will review all cases known to be released within the next 12 weeks, with a focus on those likely to be assessed as being of no fixed abode or with an accommodation need
- Actions arising from these meetings include the completion of the Duty to Refer, a referral to Commission Rehabilitative Service and potentially the referral to CAS3

Bromley Community Safety Partnership Strategy 2020-2023

2023/24 Quarter 1 (April – June 2023) Update

Priority 1 – Safer Neighbourhoods

Aim: To achieve reductions in the following crimes that are deemed by MOPAC, the Police and residents to be local priorities:

- Non-domestic violence with injury
- Crime against the elderly and vulnerable (financial abuse)
- Residential burglary
- Anti-social behaviour

Update

- During Q1 the Council Trading Standards Team received 49 complaints from residents in respect of doorstep crime and scams. The total consumer detriment associated with these cases was £132,295.
- A total of 27 calls were made to the Doorstep Crime Rapid Response number, resulting in 3 urgent responses to residents who were at immediate risk of losing money to a scam or rogue trader. One intervention saved a vulnerable consumer £1,650.
- Twenty advice and education talks have been delivered to local community groups and partners on how to recognise a scam, with a total of 350 people in attendance.
- The total estimated saving in Q1 in relation to healthcare and health related quality of life, together with estimated future savings following the intervention of the Council Trading Standards Team are £130,835.
- The CCTV Control Room actively support the police with 94 arrests in Q1, they also provided 94 evidence packs to the Police and 41 evidence packs for other regulatory activity.
- Partnership Community Impact Days (CIDs) have taken place each month to address hot-spot areas and reduce the number of reports for ASB, fly-tipping, arson, graffiti, weapons, nuisance vehicles. Agency representatives from the Council Environment and Public Protection Division and Police Safer Neighbourhood Teams regularly attend and they are joined by other agencies as appropriate to the area. The CID's have been well attended by the public.
- The ASB Panel continues to meet and provide a multi-agency approach to tackling problem behaviours by individuals leading to ASB. Standing members are the South East London Integrated Care Board (SEL ICB) Police Safer Neighbourhood Teams, registered social landlords (RSLs), mental health support services (Oxleas), Adult Safeguarding, Children's Services, Change Grow Live, Public Protection.

- The Police Safer Neighbourhood Team (SNT) have provided advice and equipment to people who have been victims of crime e.g., Smart water, Catalytic Converter marking, home security advice, Crime prevention events & working alongside 'Designing Out Crime' teams.
- The SNTs have also undertaken school visits, safer schools interventions and provided access to activities for young people to help them make good choices and divert them from ASB and crime.
- The Police, Council and LA & BDAS continue to monitor, sign-post and safeguard vulnerable individuals at risk of alcohol or substance misuse.

Priority 2 - Violence Against Women and Girls

Aim: To reduce violence against women and girls, change the culture that allows this to happen, and empower them to take control, in doing so we will:

- Better protect women and girls
- Improve support for those affected
- Target offenders

Update:

- Recommissioned victim survivor service BCWA with an increased budget.
- Developed LBB DA web pages to include services, advice and guidance to victims, parents of victims, perpetrators and professionals. This includes a safety button on all LBB websites DA pages for safe exit. <u>What is domestic abuse?</u> (bromley.gov.uk)
- Developed a professionals directory available on LBB sister sites Parenting hub, BSAB and BSCP. <u>Domestic Abuse Professional's Service Directory - Bromley</u> <u>Parenting Hub</u>
- Developed the training package further by identifying and sourcing specialist training: Protection orders, working with perpetrators, sign health, Gypsies and Travellers, Harmful practices: supporting women and girls at risk of forced marriage and FGM in the style of lunch and learns to increase accessibility to staff.
- DA training is now mandatory across Children's Social Care.
- Engaged victim service BCWA with Community Safety Impact Days to broaden reach and support partnership working
- Successful 'Walk and Talk' initiatives have been conducted in the High St, alongside Bromley Town Centre Team officers which resulted in positive public engagement with this campaign, providing feedback to officers about ASB issues, and, specifically, how to help blind females. Work is progressing on further events which will focus on providing friendly and safe environment for females and their families at football matches.
- Two Op Vigilant events have been held in Bromley Town Centre and Beckenham High Street. Utilising the resources available from the TAC teams & licensing

teams to target potential suspects from harassing women during night-time economy periods. Further Op Vigilant initiatives towards Autumn/Xmas periods.

- Multiple agencies attended Ask 4 Angela training held at the Churchill Theatre this was arranged in partnership with Bromley BID & the Safer Business Network.
- Across the South London Police Area (Bromley, Croydon and Sutton) 47 Domestic Violence Protection Orders (DVPO) and 21 Stalking Protection Orders (SPO) have been issued at court.
- A series of 'Lunch & Learn' domestic abuse awareness raising sessions are being planned a range of agencies invited to attend.
- Point of Contact stall held in Bromley High Street open to the public who were able to stop and chat to officers about VAWG concerns in the area in confidence.
- SEL ICB (Bromley) has funded the Identification and Referral to Improve Safety (IRIS) Service in Bromley. IRIS is a programme of evidence-based, effective and cost-effective intervention to improve the general practice response to DA and is nationally recognised. The IRIS Service delivered education and training to Bromley GP practices on the identification and appropriate referral of victims of DA.
- SEL ICB additional commissioned an IRIS GP Clinical Lead to support local GP practices by promoting DA services and to attend appropriate steering groups, and professional DA forums, including the Bromley MARAC meetings.
- The SEL ICB Safeguarding Team continues to chair and manage the DA Health Forum attended by health provider representatives. The forum's purpose is to build a whole Heath model of responses to DA in Bromley through:
- Acknowledging that DA is an issue deserving of a whole Health partnership approach.
- Having oversight of the local response to DA in Health.
- Mapping provision of DA support across the local health economy, identifying gaps and escalating accordingly.
- Providing a platform to optimise multiagency Health partnerships to achieve safe responses for victims/survivors.
- Providing the means for members to share good practice, including the identification of funding opportunities.
- A Safeguarding Adults Review (SAR) highlighted risk factors relating to the Domestic Abuse of Older Persons. The GP practice where the patient who was the subject of the review was registered, implemented a practice led learning event led by the Independent Domestic Violence Advocate (IDVA) of the Bromley ICB commissioned IRIS service.

• The SEL ICB has Designated Professionals for Children and Children Looked After, as senior professionals, clinical experts and strategic leaders, are a vital source of safeguarding advice and expertise for all relevant organisations and agencies but particularly the Integrated Care Board, NHS England, and the local authority, BSCP and for advice and support to other health practitioners across the health economy. The Designated Professionals (CYP) contribute to multi agency subgroups and work on the strategic priorities of the Borough and SEL.			
•	 A number of multi-agency panels continue to meet to ensure effective strategies are adopted to safeguard children and young people, these include the Multi- agency Child Criminal Exploitation (MACCE) and the Missing, Exploitation and Gang Affiliation (MEGA) Panel. These meetings are attended by various Council, Police and Health representatives. 		

• The Health Forum provides a professional network for Named Safeguarding Professionals (Nurses and Doctors) across the NHS and Private Sector and has attendance from public health colleagues including Change, Grow, Live where themes, trends, workstreams are discussed.

Target offenders

- LBB are now coordinating the Domestic abuse perpetrator panel (DAPP) and developed a new model to align with Bromley needs
- Supporting the roll out of the pan London Drive model
- Identified specialist training for staff working with perpetrators and added to the DA training package.
- Delivered workshops to DA partnership to support understanding of diversion work with perpetrators

 Priority 4 – Stand together against hate crime and extremism

 Aim:
 To improve reporting of hate crime and to reduce repeat victimisation of victims of hate crime.

Update:

- The Police are undertaking daily calls to victims of Hate Crime following victimisation / criminal allegations being made, focusing on quality-assurance and Victim Care. Working with partners such as Housing Authorities, Social Care and the LA, and organisations who specialise in Hate Crime such as CATCH and Broken Rainbows, to achieve the best outcome for all victims of hate crime and extremism.
- Quarterly GP Practice Lead Forums delivered by ICB Adult and Child GP Safeguarding leads are held to deliver topics including Prevent.
