1. Reason for report

1.1 To provide the Licensing Sub-Committee with information supporting them to determine this licence application.

2. RECOMMENDATIONS

2.1 The Licensing Sub-Committee asked to determine this application having considered the Council's Statement of Licensing Policy 2021 to 2026 and written and oral representations by the applicant and objectors.

The Public Health Nuisance Team and The Licensing Authority both raised representation to this review.

Summary of Responsible Authorities comments: Both fully support the actions of the police in bringing this review. It is also important to protect and maintain our environment so that residents, visitors and other businesses can enjoy the opportunities for living, visiting and working within the Borough safely and free from Crime, Disorder and Nuisance, it is for these reasons they take their responsibilities under the Licensing Act very seriously and uses all the available powers to promote the four licensing objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm
- 2. The full response is contained in appendix 3

Residents and interested parties

1 representations were received from residents. 0 representation was received in support of the review.

3. COMMENTARY

3.1. Licensing Act 2003.

The Licensing Act 2003 states that any premises requires a licence/certificate issued by the Council (premises licence/club premises certificate) where the following activities occur:-

Provision of regulated entertainment

- a) Plays. (Where the audience exceeds 500 people)
- b) Films.
- c) Indoor sporting events. (Where the audience exceeds 1000 people)
- d) Boxing or wrestling entertainment.
- e) Live music. (subject to the Live Music Act 2013 exemptions)
- f) Recorded music.
- g) Performances of dance. (Where the audience exceeds 500 people)

Provision of late-night refreshment (between 2300hrs and 0500hrs).

Supply of alcohol (on and off sales).

The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

The sale by retail of alcohol by or on behalf of a club to a guest of a member of the club for consumption on the premises where the sale takes place.

Licences/Certificates may be issued subject to any terms, conditions or restrictions the Council feels are appropriate to address any or all of the four licensing objectives.

The Council has previously agreed Bromley's Statement of Licensing Policy for the Period 2021 – 2026.

The Licensing Sub-Committee must consider the Statement of Licensing Policy and any Special Policy of Cumulative Impact currently in force when making any decisions in respect of these applications.

Members' attention is drawn to the Guidance adopted by members on Review Applications in **Appendix 5**.

Description of the Premises

The site sits on Beckenham High Street and comprises of a split level premises which has access from both the Car Park of Beckenham Railway Station and directly from the High Street on the narrow pavement by the Railway Road bridge. A satellite image and street view of the premises are contained in **Appendix 4**.

The premises has held a premises licence under the Licensing Act 2003 since it 2005. The licence has remained in the hands of the current licence holder throughout this period.

It has been subject to several Full and Minor variations through this period and was subject to a previous licence review in November 2014.

The Licence is subject to 37 conditions 8 of which were placed on the licence following the review in 2014.

In November 2021 a minor variation was placed which added the following condition

11. There shall be no new admission of the public after a 'cut off time' that will be decided upon by either the police or licensing authority only. The cut off time will be based on an assessment of recent crime and anti-social behaviour attributable to the activities of the premises and notice of any change to the cut off time by the police or licensing authority will be given to the premises in writing at least 3 days prior to the date a new cut off time will be effective. The cut off time for new admission of the public will not be later than 01:30 on any night or earlier than 00:00. There must be a notice clearly displayed outside the club stating the last time of entry.

This effectively gave the police and licensing authority a route to manage the access time to the premises without the need to revert to a formal variation of the premises or review. This condition has been engaged by the police since it was placed on the licence.

In the last year incidents of crime and disorder have resulted in this review being placed.

A copy of the current licence can be found at **Appendix 2**.

Details of the Application

An application for a premises licence was made on 26th April 2023 by PC Ryan Milles of the Metropolitan Police Service18th March 2021

The police review states that over the last four months alone there have been several incidents violent/disorder offences where reports have been submitted and arrests made at the premises, with further reports of disorderly behaviour outside being experienced by the uniformed colleagues.

Despite engagements with the premises on each occasion the incidents of crime and disorder continue

A copy of the full application form is contained in **Appendix 1**.

Representations

During the public consultation period the Council received representations against the application and in support. Copies of these are contained in **Appendix 3**.

4. IMPACT ON VULNERABLE ADULTS AND CHILDREN

- 4.1 Licensing regimes provide for additional controls through specific permissions to undertake activities. Both the Licensing Act 2003 and Gambling Act 2005 contain licensing objectives which seek to protect vulnerable groups. In the case of the Licensing Act 2003 it seeks to protect children from harm whereas the licensing objectives under the Gambling Act 2005 are wider and seek to protect children and vulnerable adults from being harmed or exploited.
- 4.2 Businesses and the Council are required to promote these objectives in the way they operate or make decisions.
- 4.3 Details of applications under both Acts are referred to the appropriate safeguarding teams for comment. None were received in this instance.

5. TRANSFORMATION / POLICY IMPLICATIONS

- 5.1 Both the Licensing Act 2003 and the Gambling Act 2005 require the Council to prepare, consult on and publish statements of their licensing policy. These must be reviewed at least every 5 years under the Licensing Act and 3 years under the Gambling Act.
- 5.2 Members should make decisions in accordance with these polices but are free to depart from them with good reason.

In the event of a successful appeal, we could pay the costs of the appellant as well as our own. Equally if we successfully defended an appeal, it is open to the Court to order our costs to be paid by the appellant.

Members of the Licensing Sub-committee,

The Metropolitan Police submit this application to review the premises licence for the Bridge Bar, 2-4 High Street, Beckenham, BR3 4XS. Premises Licence No. 21/01021/LMPRE.

The review is sought under s.51 of the Licensing Act 2003, under the grounds of Public Safety and the prevention of Crime and Disorder.

The premises is located on the busy main Beckenham High Street, nearest to Beckenham JCN BR Station and surrounded by other similar late night entertainment venues. The venue has residential premises situated in nearby surrounding streets, with other residential premises above nearby venues along the High St.

The venue itself is split over two floors, with entrances able to cater for both, with one on the High St leading to the 1st Floor (Upstairs), and the other more secluded in a car park area to service the ground floor, accessed via Rectory Road.

The venue has been operating at its current location for a considerable number of years, with the owner, Michael Chapman, being in charge for the past 40 or so years from when it was named 'Langtry's' onwards. The Current DPS, Jason Orris, has also been employed at the venue in varying capacities for a number of years prior to it becoming 'Bridge Bar'.

Crime and disorder

13th November 2022

3323157/22 – GBH Door staff used weapon to assault Member of Public 3323158/22 – GBH Glass thrown at person inside venue CAD 0203/13NOV22

At approximately 0023hrs a group of males have had an altercation with door staff outside the venue, whilst operating on the Lower Ground Entrance on Rectory Road. One of the males are seen to throw a punch at one of the older door supervisors, hitting him in the face where he has fallen to the floor. Following this, another door supervisor is seen to repeatedly punch and kick one of the males in the group from behind, as well as another being seen to kick one of the group in the stomach.

A member of the public is recording the incident on their phone, which has been distributed via mainstream social media. During the video, one of the door staff is seen to retrieve an object from his pocket and place it over his knuckles before running up behind a male and punching him in the back of the head causing him to stumble and fall. The object used is a knuckle-duster.

At the same time, a separate report was logged, whereby a female attendee at the venue had thrown a glass inside the venue, which has smashed across a males head causing injury. A large amount of blood loss was



visible. This incident apparently took place due to another male lifting the woman up from behind causing her to become agitated, where she proceeds to slap him. After a short period of time she proceeds to throw a glass/champagne flute in his direction, however, hitting the wrong person.

This has been viewed via CCTV, where both parties appear to be intoxicated, further corroborated by the crime report, where it was deemed unsuitable to obtain statements due to levels of intoxication at the time of the offence.

16th November 2022

Police Engagement and Follow up Letter (RDM/1)

Police licensing have attended to review footage of the incident.

Upon review of the footage it was established that one of the external cameras nearby to the door entrance was defective, offering no footage from that angle, and not in compliance with current licence conditions, as follows:

- 12. The premises will have an approved, effective and well managed CCTV system, installed/maintained by an NST Nacoos Gold Standard/SSAIB registered installer. The system installed shall be subject to a regular maintenance contract to ensure it is always fully operational, as stipulated/recommended by the installer.
- 13. The system must be in working condition, in use and recording at all times that licensable activities are taking place (and whilst people remain on the premises). It must be able to record in all lighting conditions and the images recorded must be of a good evidential standard. These images must be kept on a secure database and be capable of being downloaded on to removable media. A member of staff must be present at all times who can both operate the system and supply copies of these images on request to either the Police, Council or other authorised officer. The recordings shall be kept for a minimum of 31 days.

The Security Staff in possession of an offensive weapon is also seen to not be displaying his SIA security badge on his clothing.

At the time of the incident, Bridge Bar were utilising their own security door team, with officers making recommendations to employ the use of an agency to supply door staff to the venue.

Following attendance, a letter has been drafted and sent out covering breaches highlighted above and recommendations. Exhibited as RDM/1

For both the knuckleduster and Bus incident, the venue were operating on Temporary Event Notices, whereby an extension of their operating hours were sought from 0300hrs - 0400hrs.

18th December 2022

3325746/22 - GBH/RTC CAD 0139/18DEC22

At 0025hrs a male has been escorted from the Bridge Bar by SIA Door Staff employed at the venue for being too intoxicated. The male has been ejected via the High Street entrance to the venue. Upon removal from the venue the male has ended up in the road just as a No. 54 Bus was passing, which has hit the male causing an injury to his face requiring hospital treatment and other muscular aches and pains as a result of falling to the ground.

Police have attended the scene prior to the male going to hospital where it was acknowledged that he was extremely intoxicated and was unable to provide an account of what had happened.

The report is a third party report initially made by a concerned member of the public, who questions the force applied by door staff.

The report further states that upon impact from the bus the door staff do tend to the male and move him out of the road



11th February 2023

Police Engagement/Compliance Visit and letter (RDM/2)

Police licensing have visited venue at 2330hrs where two licence breaches were highlighted. Recorded as follows:

- 28. The premises shall maintain a dedicated telephone line which residents can call at any time up to half an hour after closing time of the premises.
- 29. The premises licence holder shall hold a meeting with the local community at least quarterly. Details of the meeting shall be provided to local residents association and shall be clearly displayed at both entrances to the premises

At the time of attendance the dedicated phone line was not turned on or charged, with Police being informed that it is usually checked every few days.

The meetings have admittedly by staff not taken place for a considerable time.

These breaches and Police attendance were recorded and sent out by means of a letter dated 14th February 2023 and exhibited as RDM/2.

26th February 2023

3304147/23 - GBH 3304366/23 – ABH on a Constable CAD 674/26FEB23

At approximately 0223hrs a white male with a black T-Shirt is seen to leave the Bridge Bar at the High St entrance and speak to a male outside. There is a brief exchange of words between two parties, which appears heated. At this time, a member of Bridge Bar Management (Michael) was outside the venue and has engaged with the male in the dark T-Shirt as a means to reduce any conflict. The CCTV is not audible and it is unclear what is said, however, the male with the black T-Shirt suddenly turns to Michael and punches him in the face with his right hand, connecting with Michael's left cheek, where Michael is seen to fall to the floor and lose consciousness briefly.

The male makes off by walking further up the road and is captured on CCTV. The male whom he had initially had a verbal altercation with was also walking in this direction slowly behind. Police can be seen to approach in a van/mini bus with blue lights. The vehicle stops near the male at which point he chases the other male and is seen to punch him in the face in the middle of the road, right in front of Police. This male falls to the floor and also loses consciousness.

Police have detained the aggressor/suspect for both incidents on the floor in the road, where officers have also been assaulted.

The injuries, as a result of these offences, constitute GBH and ABH.

The male was described as heavily intoxicated and admitted in interview to have drank far too much to the point that he has blacked out and doesn't remember what happened.

Engagement was made with the venue by means of a telephone call to check on the welfare of Michael. Officers have attended and obtained CCTV footage of the incident for review, with no subsequent follow up letter.



18th March 2023

3305645/23 - GBH with Intent, 3305640/23 - Affray CAD 519/18MAR23

Police have been called following disorder taking place in the High Street at 0130hrs, where several males were seen to be fighting.

One Male has received a stab wound to his abdomen, with another being treated by LAS to a possible acid attack, where he had been sprayed in the face by a noxious substance squirted from a Lucozade bottle. Various other parties were involved, however, made off on sight of Police.

Following review of Local Authority and venue CCTV, it has been established that many of the group involved had been inside the Bridge Bar for a considerable time prior, with many bypassing the front desk and not scanned in utilising Club-Scan, with some also not having been searched at all. Those who had, had a very basic cursory search consisting of a bag inspection, without the removal of any articles, and lighting brushing against clothing nearby to visible pockets.

At one point a Door Supervisor has called out to one of the males to return to the desk to scan in, however, the male refuses, and nothing further is done.

The venue operate a strict dress code policy of no hats, man-bags, hoodies or sportswear which is advertised both on their website and at both entrances to the venue. These were breached multiple times by various patrons frequenting the venue throughout the course of the evening.

The venue have openly breached their own policies to make allowances for certain patrons to enter the venue, many of whom were involved in the disorder and either bypassed door staff without being searched, or by passed the Club Scan system to avoid detection, showing a lack of control by door staff and management at the venue, both of whom openly witnessed these actions. Many of these people were also observed to have an overly friendly relationship with staff at the venue.

Members of this group are seen through the course of the evening coming and going from the venue, where they exit via the High St end and proceed to have a cigarette. On occasion groups are seen to walk off camera and are not being monitored by door security. There is no search on re-entry in place at the venue upon their return.

During the incident, members of the group are seen to be involved and return back to the venue, one of whom was spraying a substance at someone in the road, this is nearby to the entrance of the venue where door staff are situated. This male was allowed to go straight back in to the venue unchallenged.

Door staff all enter the venue and lock the outside door due to safety concerns due to visibility of a knife. Moments later the same male has rallied a group together inside the venue and approach the door, where a Door Supervisor opens the door and lets them rush/spill out in to the street, one of whom has pulled his t-shirt over his head in an attempt to obscure his identity. This male had also bypassed the club scan machine on entry that evening and does not show up on the club scan report supplied by the venue.

There were also persons admitted to the venue without any form of identification used, where details cannot be verified.

The male who received stab wounds was also in the venue that evening. Upon engagement with Police and LAS, it was clear that he was heavily intoxicated.

Officers have reviewed the CCTV and identified several persons who are party to the disorder, one of whom is only 19 years of age, despite the venue operating an over 21's venue. This male has also breached dress code conditions, is not on the records for club scan for the evening and was not searched on entry.

CCTV from the venue was requested, whereby, it was established that 5 minutes of footage were absent for the outside area of the venue between 0130hrs – 0136hrs, which coincidentally is the exact time of the incident, and would arguably offer the best evidence of offences. In breach of their current licence conditions, as highlighted below:

- 12. The premises will have an approved, effective and well managed CCTV system, installed/maintained by an NST Nacoos Gold Standard/SSAIB registered installer. The system installed shall be subject to a regular maintenance contract to ensure it is always fully operational, as stipulated/recommended by the installer.
- 13. The system must be in working condition, in use and recording at all times that licensable activities are taking place (and whilst people remain on the premises). It must be able to record in all lighting conditions and the images recorded must be of a good evidential standard. These images must be kept on a secure database and be



capable of being downloaded on to removable media. A member of staff must be present at all times who can both operate the system and supply copies of these images on request to either the Police, Council or other authorised officer. The recordings shall be kept for a minimum of 31 days.

20th March 2023

Police Engagement/Site visit and letter (RDM/3)

Police Licensing Dept attended the venue on Monday 20th March 2023, where CCTV was requested and partially reviewed on site as well as discussing dress codes, which were obviously not being adhered to. Officers also queried that having conducted intelligence checks on telephone calls made to Police, there are no records of the venue or any member of staff contacting the Police, where Phil Trump was able to show a 5min 34sec recording period on one of the venues telephone devices, where the venue were on the Phone to Police, however, were unable to get through.

29th March 2023

Police Engagement/Site visit and letter (RDM/4 and RDM/5)

CCTV was collected on Thursday 23rd March 2023, with officers re-attending again on Wednesday 29th March 2023 to collect internal CCTV of the venue, with our interaction being recorded on body worn video, exhibited as RDM/4.

During the course of this meeting, Police proposed the following measures:

- Reducing operating hours from 0300hrs to 0200hrs with a last entry of 0030hrs.
- Closure of the High St entrance and to operate solely from the Beckeham JCN entrance on Rectory Road to assist with public safety.
- Conditional Search on re- entry.
- Implementing a strict dress code policy.
- No ID/No Entry.
- Employing an independent/accredited door team.

These additional measures are both necessary and relevant to promote the licensing objectives of public protection and the prevention of crime and disorder.

Reducing the last entry hours and closing times will reduce footfall at the entrance to Bridge Bar when other similar surrounding venues conclude their business.

Members of the public were seen standing in the street intoxicated, with both the entrance to the venue, foyer of the venue and queue outside of the venue merging to such an extent that you cannot clearly see, or make out who has been in the venue and who hasn't.

Closure to the high street entrance will also aid public safety, by keeping pedestrian foot traffic to a minimum on a busy, narrow high street, as well as allowing for the venue to manage its Search Policy & smoking area more effectively.

Conditional search on re-entry is a policy that the venue had adopted to all of its staff in November 2022 following an incident whereby a staff member is seen to hit a member of the public with a knuckle duster. All documents and were provided to Police on 16th November 2022.

This policy needs to be implemented to patrons too in relation to public safety.

Persons are seen to leave the venue, walk out of sight and return minutes later completely unchallenged. Implementing a strict dress code Policy will detract those who undermine the venue from attending. Which is wholly apparent from provided CCTV footage.

Providing identification on entry, and when scanned in provides an evidential foot print of attendance at the venue, which will support all 4 licensable objectives.

Employing an independent accredited door team allows for flexibility and movement of staff where standards fall short of what is expected.

Following attendance a letter was drafted covering the above topics. Exhibited as RDM/5



3rd April 2023

Bridge Bar letter of response (RDM/6)

The Police have since had further engagement with the venue, and are in receipt of a letter dated 3rd April 2023, whereby the venue have requested that the High Street entrance remain open to allow for an over 25's cocktail lounge, with the downstairs operating as an Over 21's Nightclub; requesting an extension to last entry times at the venue; and requesting that they continue to manage their own door team, despite most recent and historic issues that have resulted in serious injury and criminal procedures.

Please note, that due to the on-going live criminal investigation, a copy of some of the crime reports are not being provided at this time. The relevant information is however summarised in this statement. A heavily redacted report can be provided upon request if required.

If submitted I will exhibit the following crime reports as follows:

RDM/7 – 3323158/22, glassing incident on 13th November 2022

RDM/8 – 3325746/22 – Road Traffic Incident involving Bus on 18th December 2022

Public safety

The venue operate a smoking area on the footpath on the High St, by the entrance to their venue. There is also a queueing system in place at the point. The pathway is quite narrow and with other local venues, the footfall often spills in to the road causing safety concerns for pedestrians who are also under the influence of alcohol which only exasperates the issue further.

As mentioned above, a male has been ejected from the venue in to the path of oncoming traffic, whereby, he has sustained injuries that could have been far worse.

This male was apparently being ejected due to being too heavily intoxicated, with further reports suggesting similar issues, whereby, both emergency workers, staff and members of the public have all been assaulted.

The Police strongly believe that due to the ineffective/poorly managed queueing system, merging with the smoking area it has been identified that persons are able to access the venue without being searched or being scanned in utilising club scan, which can result in weapons, drugs or other prohibited material being brought in to the venue unchallenged.

At this point in the submission, the Police would like to refer you to your Statement of Licensing Policy:

SEC 31 of the Bromley Statement of Licensing Policy 2021 – 2026

The Licensing Authority has instructed its officers to adopt a zero-tolerance approach to offences and breaches of licence conditions. In practice this means that licensing officers will investigate significant complaints alleging breaches of the Act or licence conditions and act on all sources of reliable intelligence (including local residents and businesses) with a view to establishing if offences have been committed. Such matters may include:

- Unauthorised licensable activities or breach of licence conditions
- Allowing disorderly conduct on licensed premises
- Sale of alcohol to children and the consumption of alcohol by children
- Sale of alcohol to a person who is drunk where licensing officers have such evidence, they have a range of enforcement options including:



- Offering advice /guidance (verbal or written)
- · Informal written warnings
- Formal cautions
- Prosecutions
- Review of Premises Licences where there are problems associated with crime and disorder, public safety, public nuisance or the protection of children from harm
- Closure of premises that are experiencing or are likely to experience crime and disorder or public nuisance.

The Police would also like to refer you to the revised guidance under section 182 of the Licensing Act 2003:

11.10 Where authorised persons and responsible authorities have concerns about problems identified at premises, it is good practice for them to give licence holders early warning of their concerns and the need for improvement, and where possible they should advise the licence or certificate holder of the steps they need to take to address those concerns. A failure by the holder to respond to such warnings is expected to lead to a decision to apply for a review. Co-operation at a local level in promoting the licensing objectives should be encouraged and reviews should not be used to undermine this cooperation.

Bromley Police Licensing regularly engage with the venue, and conduct visits where deemed necessary. During the above listed incidents the Police have highlighted several issues inclusive of; intoxication levels, defective CCTV cameras at varying locations during disorder, lack of engagement with local residents through scheduling of regular meetings, as well as identifying failings within door security, in-effective queuing systems, poor/no searches taking place, use of force and not implementing use of Club Scan, all of which are agreed conditions within their current licence.

During the most recent face to face engagement, there was also misleading information provided to Police about club-scan, as well as initially being informed by the venue that no patrons from the venue were involved in the disorder and defective CCTV at crucial locations.

The Police are of the opinion that the premises has failed to comply with the current conditions within the licence and when engaged with, they have dismissed most of the recommendations. As such, the Police have no confidence that the venue will adhere to any new conditions that could be added by the Licensing Sub-Committee. Because of this, the Police ask the Licensing Sub-Committee to revoke the current Premises Licence.

The Police thank the Bromley Licensing Sub-Committee for its consideration of these matters and am happy to assist with any further clarification if required.

Dear Mr Orris

On Sunday 13th November 2022 at 0023hrs Police have been called to 'The Bridge Bar', 2-4 High St, Beckenham where a male had been assaulted by a female inside the venue, upon arrival a further incident had taken place outside which took precedence.

An allegation of Assault by door staff, with one said to be using an offensive weapon, namely a knuckleduster.

The incident had been recorded and was viewed by Police on scene. This has since been circulated via mainstream social media platforms.

On Wednesday 16th November PC Dandridge and PC Mills attended the premises alongside Bromley Council Licensing to view the CCTV footage and to discuss the incident with yourselves.

From viewing the CCTV it has been established that one of the external cameras nearest to the entrance door was defective, and could not provide clear/legible footage. This is said to have been water damaged a couple weeks prior and is due to be repaired this coming Friday.

As it stands the CCTV in its current state would not comply with your license conditions:

'12. The Premises will have an approved, effective and well managed CCTV system, installed/maintained by an NST – Nacoss Gold Standard/SSAIB registered installer. The system installed shall be subject to a regular maintenance contract to ensure it is always fully operational, as stipulated/recommended by the installer.

13. The system must be in working condition, in use and recording at all times that licensable activities are taking place (and whilst people remain on the premises). It must be able to record in all lighting conditions and the images recorded must be of a good evidential standard. These images must be kept on a secure database and be capable of being downloaded onto removable media. A member of staff must be present at all times who can both operate the system and supply copies of these images on request to either the Police, Council or other authorised Officer. The recordings shall be kept for a minimum of 31 days.'

The video shared online clearly shows one particular door staff member repeatedly kick a male whilst on the floor, as well as repeatedly punch another from behind, before being seem to remove an article from his right pocket, put it over his right knuckles, before running up to a male with his back turned and punch him in the head whilst he was walking away, as another staff member kicks him in the stomach.

This male with the offensive weapon is also wearing a dark jacket, and cannot be clearly identifiable as door staff, where his SIA badge is not at all visible.

PC Mills and PC Dandridge alongside Council officers have spoken at length regarding the necessity to remove the two highlighted Door supervisors from the venue immediately as well as the need to replace all door staff at the venue and to utilise a reputable external SIA security company to provide experienced staff.

Discussions also took place regarding a conditional staff search on entry/re-entry and exit from the venue following the highlighted issues.

Officers have also reviewed CCTV of the initial assault for which the Police were called, whereby a female had thrown a glass, which has hit a male patron on the head and caused injury.

With the impending World cup dates fast approaching, officers have also suggested whether planning on showing the Football or not, that Polycarbonate glasses are utilised to reduce the risk of injury accidental or otherwise, during a period where venue volume could be significantly higher and behaviour may become more volatile.

A meeting will be arranged to take place in the coming month to assess the effectiveness of the changes made.

On Saturday 11th February 2023 PC Dandridge and PC Mills attended Bridge Bar in order to conduct a full compliance visit.

After observing the door team working the entrance to the premises and having a walk around inside the venue we went to the office area with Phil Trump where we conducted a full compliance check of the Premise Licence 21/01021/LMPRE.

Two breaches of the premises were identified as follows:

Condition 28: The premises shall maintain a dedicated telephone line which residents can call at any time up to half an hour after closing time of the premises

Phil Trump gave us a business card which was a residents hotline with the telephone number 07483135416 and the following wording written on it "Available during trading hours and up to half an hour after closing "However the mobile phone was not available to see and Phil Trump admitted it was not turned on or charged up but was usually checked every few days. He also mentioned

that he was aware that one resident definitely had the hotline number. PC Dandridge explained that this phone must be on and active as per condition 28.

Condition 29: The premises licence holder shall hold a meeting with the local community at least quarterly. Details of the meeting shall be provided to local residents association and shall be clearly displayed at both entrances to the premises.

Phil Trump admitted that these meetings have not taken place for some time. PC Dandridge explained that if this condition was no longer relevant or required that it could be removed by way of a minor variation.

It was then explained to us by Phil Trump that the management had been in discussions and had decided to withdraw the application to vary the Premises Licence. A meeting is to be arranged with the venue operators, police and council to discuss the operation of the premises moving forward.

Dear Mr Orris

On Saturday 18th March 2023 at 0130hrs various calls have been made to Police from members of the public, as well as being picked up on CCTV in relation to large scale disorder taking place on High Street, Beckenham nearby to Bridge Bar/Patricks Bar.

Upon review of CCTV footage from both the Local Authority and from yourselves it has been established that a number of those involved have come from inside your venue.

From the context of the calls made and footage available, it is clear to see that both bladed articles and noxious substances are being used.

One of the males seen to use a spray bottle believed to contain a noxious substance is also seen to enter your venue following the disorder.

A number of males are also seen to 'rush' out of the venue to carry on the disorder before returning minutes later and re-entering unchallenged, despite one attempting to obscure his identity by having his T-Shirt/Jumper pulled up over his face.

The fact that these males are seen to leave the venue and re-gain access without challenge is quite concerning, as prohibited articles/objects could quite easily be carried in to your venue.

One male patron from your venue who was clearly heavily intoxicated with suggestion that he is also heavily under the influence of other substances has been injured as a result of the disorder, whereby he has received a stab wound to his stomach. He is seen to return to Bridge Bars entrance and upon being unable to gain access has smashed the door by hitting and kicking it, prior to picking up a pole at the entrance which he throws in the road in front of him.

The dress code has also raised concerns as both Hats, 'Man Bags' and hoodies were seen to be used by several attendees at the venue including the male who was using the noxious spray despite dress code conditions clearly displayed on both front and back doors prohibiting both articles of clothing, as well as Trainers and T-Shirts also being worn.

A request has been made for Club Scan Records to be retrieved for the evening of Friday 17th March 2023 – Last Entry times at 0130hrs on Saturday 18th March 2023.

On attendance on the 20th March 2023 sadly these records were unavailable due to technical difficulty. I am of the understanding that these records should be available in the coming days.

As it stands, without the capability to review the Club Scan records, and without a thorough review of CCTV to assist with our investigation, and the fact that the disorder has taken place around last entry times for your venue and closing times for neighbouring venues, it has been agreed by Police and Council to utilise Condition 11. Of your licence conditions and implement an earlier last entry time of 0000hrs until further notice.

A meeting will be arranged to take place in the coming weeks to assess the effectiveness of the changes made.

Re: Police Visit on 29/03/23

Dear Mr Orris

On 29th March 2023 myself and PC Mills attended Bridge Bar and met with Michael Chapman, Phil Trump and yourself to further discuss the incident that took place on Saturday the 18th March 2023 following the initial review of the Club Scan records and some of the CCTV that had been provided to Police.

The following observations that we made were explained to you:

Some people seen entering into the venue were not detailed on the Club Scan records provided and CCTV verified that they had not had any ID scanned into the Club Scan device.

The Club Scan records show that two males who entered were ID scanned and shown to be aged 20 years old which is below the venues age policy of 21 years however they did not leave the venue and were allowed entry. Another male who I recognised and know to be 19yrs old was seen to enter the venue without having any ID scanned or searched.

The CCTV footage provided to Police from Camera CH01 is completely missing any details between the hours of 0130hrs and 0136hrs which is during the time that the incident concerned took place.

The CCTV footage shows that people were leaving the venue and often going out of sight of the door team before returning back and entering into the venue again unchallenged or being re searched by the door team.

The venue operates a dress code which is signposted at entry points and on social media stating No Hats, Hoodies, Man Bags, Sportswear, joggers, tracksuits however CCTV shows that this dress code was not adhered to with many people entering in breach of the dress code.

CCTV also shows that the door team appear to be over friendly with people attending. The general searching of customers entering the venue was of a poor standard with some bypassing security completely and walking into the premises unsearched.

CCTV clearly identifies that there was very little control on the main entrance with customers at times able to do as they wanted and ignoring the door team. During the time that the incident was taking place and at the point the venues doors had been locked several people were seen to "rush "towards the doors which were then opened by door staff and the group entered into the street where they continued to cause disorder.

CCTV shows a male wearing a white hoodie and a man bag leave the venue and moments later is seen running in the street within sight of the door team spraying a liquid into people's faces. This male was then allowed back into the venue without being challenged or searched again.

A male who had entered the venue and then left during the incident was stabbed outside the main entrance. This male was seen on Police Body Worn Cameras and CCTV to be drunk, aggressive and possibly under the influence of other substances. This male was seen to smash the front door of the premises however this matter has not yet been reported to Police despite the male concerned being easily identified.

After taking into account all of the above and in addition to the other incidents we spoke about including when a patron was ejected by door staff and went into the path of a double decker bus directly outside of the entrance to the premises and the incident that took place where two members of the door team were identified as assaulting a male, one using a knuckleduster and one by kicking him the following measures/ additions / changes to the Premise Licence are considered necessary and proportionate in order to promote the licensing objectives:

A last entry time of 0030hrs and a closing time of 0200hrs.

A SIA accredited Door Team to be put into place at the premises A dress code to be adhered to of no hats, hoodies, man bags, sportswear. A search to be completed for any re-entry to the premises A No ID / No Entry policy

The rear entrance of the venue to be used for entry / exit which would be easier to control than the current High Street entry point, provide a safer location for the smoking area and reduce the risk of any issues surrounding public safety.

These could be implemented by way of a variation and we would respectfully ask that you let us know if this is an option for you by 3rd April 2023. As discussed during our meeting the other option is for Police to submit a review of the Premise Licence.

Dear PC Dandridge and PC Mills,

Thank-you for coming to see us on 29/03/2023 and for your follow up letter dated 30/03/2023. As discussed at the meeting I wanted to reiterate in writing that we are deeply frustrated and angry about the events that happened on the 18/03/2023 and wanted to once again reassure you that I am not taking the events (or the repercussions) lightly. I fully understand and respect both the police and the councils stance in this matter and are looking to actively work with you both in order to ensure that this never happens again.

The problems that we have had have led us to seriously reconsider the current business model and as such we have decided to completely change the avenue that we are currently on. As such, upstairs is now currently closed and we are in the process of refurbing to re-launch as a cocktail lounge. We are increasing the amount of seating available and reducing the available dancefloor area to create a more intimate and relaxed atmosphere. This would allow us to open earlier and attract a better class of customer and therefore we would no longer rely on attracting those that have left other venues at closing. It would also allow us to monitor and assess intoxication levels more effectively of customers as we would be looking to become their first port of call. All bar/floor staff will be expected to complete and pass additional training courses which will include the following:

Drinkaware Alcohol Vulnerability Awareness – designed by Drinkaware and accredited by BIIAB (British Institute of Innkeeping Awarding Body).

Drugs Awareness – accredited by BIIAB

Drink Spiking Awareness - accredited by BIIAB

As discussed, the dress code was immediately changed and is now being strictly enforced to ensure a smarter clientele is present. In order to ease congestion at the entrance upstairs we will be looking at moving the ID scanner from its current location (inside reception) and situating it at the entrance point thus eliminating any potential pinch points should there be any issues with someone's ID and therefore speed up the entry process. In relation to smokers, we would limit the numbers allowed out at any point so they can be properly marshalled and all would be re-searched as a condition of re-entry. Having the upstairs entrance is crucial for the new direction we are trying to go simply because of the presence on the High Street, without this it simply won't work.

I would also respectfully ask if you can meet us in the middle with regards to the last entry time. By pulling the time back by an hour it has a huge financial impact at a time where we simply cannot afford it. The time it takes to re-educate customers (both new and old) to a change in last entry is a long process and I hope that you would allow us to change that to 0100 instead (thus a reduction of half an hour). Although this will still result in a financial hit, it gives us a chance to be able to mitigate some of those losses as well as making the process of re-education slightly easier.

In relation to the door team, we are looking to extensively re-train them as well as replacing anybody that is below standard. We have so far received nearly 200 applications to our job advert placed on indeed.com and are currently in the process of whittling them down to the most suitable/experienced. We are against the idea of employing an agency for numerous reasons, principle of which is the cost involved in making the current staff redundant and the increased hourly cost in employing agency staff. We have also seen from other venues that the quality and experience of some of the staff provided would make them unsuitable.

The other changes that you have suggested to be made to the premises license I will accept and implement with your guidance via a variation.

Mandatory Conditions

- 1. Supply of Alcohol:
 - (1). No supply of alcohol may be made at a time when no designated premises supervisor has been specified in the licence or at a time when the designated premises supervisor does not hold a personal licence or the personal licence has been suspended.
 - (2). Every sale of alcohol under the premises licence must be authorised by a personal licence holder.
- 2. Irresponsible Promotions:
 - (1). The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2). In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—.
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or .
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;



- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner:
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

3. Free Potable Water

(1). The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

4. Age Verification:

- (1). The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2). The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3). The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.

5. Minimum Measures:

- (1). The responsible person must ensure that
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—.
 - (i) beer or cider: ½ pint; .
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and .
 - (iii) still wine in a glass: 125 ml; .



- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

6. Permitted Price:

- (1). A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- (2). For the purposes of the condition set out in paragraph 1 -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - (b) "permitted price" is the price found by applying the formula -

P = D + (D X V)

where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.



- (3). Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4). (1). Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2). The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

7. Films:

(1). The admission of children must be restricted in accordance with the recommendations laid down by the British Board of Film Classification.

OR

(2). In circumstances where the licensing authority has reclassified a film. Then access of children should be restricted to meet this reclassification standard.

Note:- "Children" means any person under 18 years of age.

8. Door Supervision:

- (1). Any individual employed at the premises as a door supervisor must
 - (a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
 - (b) be entitled to carry out that activity by virtue of section 4 of that Act.

Conditions consistent with the Operating Schedule

The premises must operate in accordance with the submitted application forms and are subject to additional conditions as specified within Part 3 (Operating Schedule) of the form held by the Licensing Authority dated **24th November 2005**

General

This premise shall operate as a nightclub with both on and off sales.

- 9. On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).
- 10. A plan and suitable notices shall be displayed clearly showing the areas, which should be used for parking cars



11. There shall be no new admission of the public after a 'cut off time' that will be decided upon by either the police or licensing authority only. The cut off time will be based on an assessment of recent crime and anti-social behaviour attributable to the activities of the premises and notice of any change to the cut off time by the police or licensing authority will be given to the premises in writing at least 3 days prior to the date a new cut off time will be effective. The cut off time for new admission of the public will not be later than 01:30 on any night or earlier than 00:00. There must be a notice clearly displayed outside the club stating the last time of entry.

Prevention of Crime and Disorder

- 12. The Premises will have an approved, effective and well managed CCTV system, installed/maintained by an NST Nacoss Gold Standard/SSAIB registered installer. The system installed shall be subject to a regular maintenance contract to ensure it is always fully operational, as stipulated/recommended by the installer.
- 13. The system must be in working condition, in use and recording at all times that licensable activities are taking place (and whilst people remain on the premises). It must be able to record in all lighting conditions and the images recorded must be of a good evidential standard. These images must be kept on a secure database and be capable of being downloaded onto removable media. A member of staff must be present at all times who can both operate the system and supply copies of these images on request to either the Police, Council or other authorised Officer. The recordings shall be kept for a minimum of 31 days.
- 14. The premises shall have no fewer than six SIA Registered Door Supervisors whenever licensable activities are taking place. One of these must be female. All must sign a register when performing duties at the premises. This register is to contain the full names, SIA badge numbers and contact details of that person.
- 15. On any night that that the premises trades beyond 2am it shall have no fewer than 8 SIA registered door supervisors working at the venue, who shall remain on duty until 30 minutes after the venue closes.
- 16. Those records are to be made available on request to any Relevant Authority for the purpose of investigating or preventing crime or apprehending or prosecuting an offender.
- 17. There shall be no off-sales from the venue, and no drinks may be taken outside by customers.
- 18. The venue shall not offer cut price alcohol promotions.
- 19. The upper and lower floors of the premises shall be closed sequentially, at least 30 minutes apart from each other.



- 20. No customers under the age of 21 shall be admitted to the premises.
- 21. Save for emergency egress, all exits after 2.30am shall be through the station park entrance.
- 22. Following stopping serving of alcohol, a minimum of 2 security staff shall be immediately deployed to marshal the vicinity in hi vis jackets to promote a quiet and rapid dispersal of customers. Whilst the remaining ensure all customers leave the premises, all security shall then be deployed to marshal the vicinity in hi vis jackets to promote a quiet and rapid dispersal f customers.
- 23. Following close of the premises, it will remove any empty vessels from the station car park.

Public Safety

- 24. All chains on other removable fastenings should be removed from all exit doors whilst members of the public are on the premises. and retained in the possession of a responsible person. The routes to the final exit doors and the area outside the final exit doors shall be kept clear at all times whilst members of the public are on the premises.
- 25. All exits should be manned or under observation at all times when members of the public are on the premises
- 26. The number of persons accommodated at any one time in the premises shall not exceed the following-

Upper Floor **200** Lower Floor **250**

Prevention of Public Nuisance

- 27. Notices must be posted in or near exit routes stating that anybody caught or seen causing a nuisance or disturbance when leaving the club will be refused future admission to the club.
- 28. The premises shall maintain a dedicated telephone line which residents can call at any time up to half an hour after closing time of the premises.
- 29. The premises licence holder shall hold a meeting with the local community at least quarterly. Details of the meeting shall be provided to local residents association and shall be clearly displayed at both entrances to the premises



Conditions attached after a REVIEW hearing by the Licensing Authority

Dispersal policy

30. A dispersal policy document is to be drawn up in consultation with Police and Council officers. Once agreed it is to be implemented in full. To include, but not limited to; (the monitoring of customers by door staff, the pre booking of mini cab/taxis, orderly dispersal of patrons, announcements and public information). This policy shall be reviewed on an annual basis to ensure it is still effective and shall be updated if necessary.

Staff Training

31. All staff will receive documented training in relation to the Licensing Act 2003, and the 'challenge' policy and the training shall be repeated every six months. Records of this training and the written policies relating to it will be kept and made available to Police or Council Officers on request.

Crime Prevention

32. At Police request (and following consultation with the premises licence holder or their representative), the venue will take part in reasonable crime prevention initiatives, including the submission of form 696 – promoted event risk assessment – if considered necessary in targeting any prevailing crime trend identified at the premises.

Risk Assessment

33. If the premises are being used for a privately booked family or business function, televised sporting event or any other special occasion then a risk assessment will be carried out by management prior to the event taking place. If deemed necessary, the management will put in place measures to negate any risk. Deliberations to include, but not limited to - appropriate number of door staff, the use of Polycarbonate glasses for all drinks, PET bottles or bottles de-cantered into drinking vessels by staff, control of customer numbers, searches of patrons – if these or any other measures deemed necessary by the risk assessment are not employed for the event in question, the management of the premises shall record the reason(s). The risk assessments will be filed at the premises and made available to the Police and Council Officers on request.

Incident Book

34. A log for all incidents is to be kept and maintained. This log must be available to Police or Council Officers on request. Relevant offences will be reported to Police in good time.



Search Policy

35. Targeted searches of customers entering the premises are to be carried out. These searches are to include the customer's person, wallets, purses, bags, and any other item carried by them. All searches to be carried out in sight of a CCTV camera. A hand held metal detector must be available for use by staff as needed. If any person is found in possession of drugs, weapons or items prohibited by the venue, these items must be seized and the person excluded. Police will be called in all cases where weapons are recovered. Ay person not submitting themselves to a search must be refused entry.

Club Scan

- 36. A photographic, ID computer based entry system (club scan) is to be installed/maintained. The system is to be capable of sharing information with other venues. It will also be able to identify the authenticity of identity documents to a reasonable standard. The system will be in operation at all times that the venue engages in licensable activities. All patrons and staff that enter the premises will have their ID documents 'scanned in' or may have 'biometric' fingerprint membership once their details are recorded on the system. The details shall be stored for a minimum of 31 days and be made available on request of a Police Officer for the purposes of detecting or investigating crime.
- 37. Persons refusing to supply identity documents or refusing to submit them for scanning into the photographic ID computer based system (club scan) will be refused entry (they shall also be refused entry if they refuse to pass through the system in any other way photograph, fingerprint scan etc.).





We are in possession of an application for a review of the above premises licence from the Metropolitan Police in relation to the following licensing objectives.

Public safety and the prevention of crime and disorder.

The application provides considerable detail of the concerns they have regarding the operation history of the premises, and the continued crime and disorder associated with the premises.

On behalf of the Environmental and public protection team as a responsible authority i have the following representation to make in relation to this application to review the premises licence.

I have reviewed the evidence supplied by the Metropolitan Police and based on the evidence supplied we would fully support the police in this review and the recommendation put forward by the police that the licence should be revoked.

On the 16th November 2022 I attended the premises in the company of PC Dandridge and PC Mills to view the CCTV footage of an incident outside the premises and to discuss the incident and operational history of the premises.

The letter submitted in support of the review by the police dated the 16th November 2022 gives further details of the visit and that the CCTV was not of sufficient standard and external cameras nearest to the entrance door was defective, and could not provide clear/legible footage and was breaching condition 12 and 13 of the premises licence.

SIA registered door staff are an important part of the safe running of a late-night venue for the prevention of crime and disorder, public safety, and the prevention of public nuisance. Confidence in the staff employed to carry out this role is paramount, and the licence holders were advised at the meeting that an SIA accredited external company should be looked at to carry out the relevant roles within the operation.

Further serious violent incidents have been reported since this recommendation and on the 30th March 2023 the police again put forward that the licence holder should employ an SIA accredited company to supply and manage the door supervisor. The failure to

implement the recommendation earlier could have resulted in violent incidents that could have been prevented.

They have several control measures on the licence that do not appear to be restricting the crime and disorder associated with the premises and the continued violent incidents inside and outside the venue which are putting police officers and members of the public at risk of serious injury.

The management and licence holder has been given several opportunities to implement measures to deal with the problems and have been given advice and support by the police and the local authority.

I believe there are no additional conditions placed on the licence that would assist, as a number of conditions already on the licence have been breached on several occasions set out within the review application.

Having fully considered all the evidence supplied within the application and available to me the only recommendation I can give is that the licence be revoked.

This is submitted for the information of the licensing subcommittee.

This representation is made by the Licensing Authority at the London Borough of Bromley as a Responsible Authority identified within the Licensing Act 2003. It is based on the London Borough of Bromley **Statement of Licensing Policy 2021 – 2026**.

Background

The Licensing Authority has a wide range of responsibilities including helping to develop and promote a strong sustainable local economy. Thriving food, drink and entertainment businesses in the Borough are an important part of that local economy and the Licensing Policy is critical to their continuing success and for attracting further investment and opportunity to the Borough. Balanced against this is the Council's legal duties and commitment with its partners to reducing crime and disorder and the fear of crime. It is also important to protect and maintain our environment so that residents, visitors and other businesses can enjoy the opportunities for living, visiting and working within the Borough safely and free from nuisance.

For these reasons the Licensing Authority takes its responsibilities under the Licensing Act very seriously and uses all the available powers to promote the four licensing objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

Through the Licensing Act 2003 the Government has provided opportunities for businesses to develop and flourish in socially responsible ways and has simplified and lightened the administrative burden of licensing. However, the policy states that the powers given to the authority will be used to the fullest extent where businesses or licence holders blatantly infringe the law or undermine one or more of the licensing objectives.

Crime and Disorder - Licensed premises, especially those offering late night/early morning entertainment, alcohol and refreshment, can be a source of crime and disorder. The Licensing Authority will expect the licence holder to satisfactorily address these issues from the design of the premises through to the daily operation of the business.

The police have provided evidence of numerous occasions where there has been crime and disorder directly linked to patrons of the Bridge Bar including use of weapons resulting in a stabbing, assault (GBH & ABH), fighting and other disorder as well as reckless endangerment and assault with a weapon committed by security staff employed by the venue.

Drugs - The Licensing Authority is committed to the reduction and eradication where possible of drugs from licensed premises as part of its role in promoting the Crime and Disorder licensing objective.

The police have provided CCTV footage where a number of people have been allowed to freely enter, leave and re-enter the premises without being searched. These individuals were later arrested and found to have drugs on their person.

Public Safety – The venue uses the narrow footpath outside the premises for both their queuing area and smoking area. There is CCTV footage showing that this area poorly managed resulting in people spilling out on to the very busy High Street road. It is in this area where a member of security can be seen pushing an intoxicated customer from the premises directly into the path of an oncoming bus, which then struck the man and knocked him to the ground.

Licensing Authorities Assessment of the Licence Holders Ability to Promote the Licensing Objectives and Comply with the Requirements of the Licensing Act 2003

The business has been given advice and support and been provided with information on a number of occasions.

The current premises licence has a comprehensive set of conditions to promote all of the licensing objectives including Crime & Disorder and Public Safety.

The management of the premises have actively engaged with the responsible authorities and are willing to put the necessary measures in place when issues arise.

However, when the premises are operating these measures do not appear to be enforced resulting in serious issues relating to crime & disorder and public safety where members of the public have been assaulted and injured.

Despite the fact the business has been engaged with the authorities and has implemented numerous measures, they have still been unsuccessful in preventing crime and disorder directly linked to activities taking place on the premises. Therefore, it is the view of the London Borough of Bromley Licensing Authority that it is appropriate to support the recommendation to revoke the premises licence at this venue.

Crime and disorder

Due to the increase in crime within Beckenham I suggest it is now prudent to assess any application for a licence premises be considered differently.

I attended a residents association meeting on Monday 24th October 2022 during which Councillor Bance MBE gave a powerful statement with regards gang-related crime and how it is spreading into Bromley town centre and the surrounding areas. There have been dreadful incidents in and close to The Glades and in Beckenham.

N.B. It is acknowledged the management of the Bridge Bar have no connection to criminal activity, but we all have a responsibility to take reasonable action to prevent criminal activity.

Previous incidents -

October 2021 - Quote from Bridge Bar

"Regarding the incident we had on Friday night, we would just like to state that the wording of the information that has been given out is slightly wrong. We did not have a stabbing at the Bridge Bar. We had an altercation between some individuals in the bar. They were removed by door staff and left. The other individuals involved then got into a car and chased after them. Unfortunately, they caught up with them somewhere in town and this is when the stabbing occurred."

June 2022

BECKENHAM: Police are appealing for witnesses following an incident at Bridge Bar on Saturday 4 June, around 11.45pm.

The incident is believed to have been a male allegedly assaulted by a bouncer and seriously injured. Police on 101, Ref CAD number 008306/04JUN22

Graffiti -

There has been an increase in graffiti in the area where the High Street leads into Southend Road. Hopefully this is insignificant, but we cannot be naive e.g., Gangs use graffiti to mark their territory, mourn fallen members and challenge rival gangs. A tag in a new area may reveal that the gang's turf has increased.

There was graffiti on the wall of the Bridge Bar facing towards the High Street which did not appear to be as a result of children being mischievous.

Attempts were made to cover the sign (tag) however it was visible for a long time..

Public nuisance

Please do not authorise the 'After Party' at The Bridge Bar for the guests of Soul Town Festival 2023.

Below are the issues in 2022 -

Soul Town Festival - Saturday 3rd September and Sunday 4th September 2022

The 'After Party' at The Bridge Bar,2-4 High Street, London BR3 1AZ, caused a disturbance.

Bromley Council approved Temporary Event Notice. Reference: Reference: 22/00842/LATEMP - End time: 02:00hrs

The event continued until 03:00hrs (?) The time advertised on the internet (?)

For residents the noise and distress in relation to Sunday 4th September 2022 carried on until the early hours of the morning Monday 5th September.

Does this CCTV outside The Bridge Bar keep a record of the time the venue opens and closes. Also, the level of the noise?

Performers of dance: This was not ticked on the application Variation reference: 23/00118/LAPRE, but I recall seeing adverts for this type of specialist theme nights especially during the after parties following the Soult Town Festival. I may be wrong but think this should be queried.

Litter and human waste

Another public litter bin is required in close proximity to the exit of the Bridge Bar, and it would be a positive gesture to work with Bromley Council to support the cleaning of the area.

It is my view the management of all the clubs and pubs in this area should collectively fund a private cleaning company to remove all the litter, debris and human waste from approximately 06:00hrs on each Saturday and Sunday. Attached is a photo taken on Saturday 6th May at approx. 08:30hrs (apologies - not pleasant)

There is no evidence it is related to the operational management of The Bridge Bar however it is one example of the consequences of the Night-Time Economy which comes at a high price for the community.

Please can clarity be provided in relation to the opening hours on the following dates

Christmas Eve, Christmas Day and Boxing Day 2023.

Sunday 24th December: Open until 03:00hrs?

Monday 25th December: Not opened

Tuesday 26th December (Boxing Day): Open until 03:00hrs on Wednesday 27th December i.e. not a public holiday.

Also, on Sunday 31st December: Open until 03:00hrs? Monday 1st January 2024 will be a public holiday.

Public safety

Potential Health and Safety issues - 5th May - photo attached.

Two step ladders were on the pavement, but a hazard warning sign was not visible. These could have caused an accident and reduces the accessibility of

the public pavement.

There appeared to be one person working without anyone else holding the ladders. This is a risk to the employee and residents if the person

fell off the ladder. I do not think this was a window cleaner. The member of staff appeared to be painting decorative designs on the glass.

This is not a negative observation on that person however another member of staff needs to be outside to support the work.

Notification was sent to the Licensing Team and acknowledgement received.


Protection of children from harm

Guidance Adopted by Members on Review Applications

Guidance for Members hearing a Review of a Premises Licence or Club Premises Certificate

Licensing Act 2003 section 52 & 88 and Part 11 of the Secretary of States Guidance

The purpose of a Review

To ensure that the licence holder is promoting the licensing objectives, which are

- 1. Prevention of crime & disorder
- 2. Prevention of public nuisance
- 3. Protection of public safety
- 4. Protection of children from harm

Reviews can be brought by any Responsible Authority, individual, business or Ward Councillors on any of the licensing objectives

At a Review Members of the Sub Committee can

- 1. Modify licence conditions
- 2. Exclude a licensable activity from the licence
- 3. Remove the DPS from the licence
- 4. Suspend the licence for up to 3 months
- 5. Revoke the licence

Seriousness

After hearing the evidence at a Review hearing Members need to decide the level of seriousness of the failure to promote the licensing objective. This guide suggests factors which Members may consider to be 'aggravating' or 'mitigating' but it is not a definitive list and Members may identify other factors during a Review hearing.

Based on Members views as to seriousness and 'aggravating' or 'mitigating' factors the suggested 'starting Point' for the imposition of actions under Section 52 can be considered and varied 'upwards' or 'downwards'.

Members are advised to note 'aggravating' or 'mitigating' factors and ensure these are recorded in their reasoned decision.
