

## Prudential and Treasury Indicators – Actual 2010/11

Prudential and Treasury Indicators are relevant for the purposes of setting an integrated treasury management strategy. The table below shows the actual performance in relation to the indicators in 2009/10 and compares the actual in 2010/11 with the original estimates approved in February 2010 and the revised estimates (“probable”) reported when the indicators for 2011/12 were approved in February 2011. Further details on capital expenditure outturn were reported to the Executive on 22nd June 2011.

The Council is required to indicate if it has adopted the CIPFA Code of Practice on Treasury Management. This original 2001 Code was adopted by the full Council in February 2002 and the revised Code was adopted by full Council in February 2010.
