1. SUMMARY

- 1.1 To consider the application by Trading Standards to review of the Premises Licence at Kwik Stop 5 Stanley way Orpington Kent BR5 2HE
- 1.2 A copy of the application to review the Premises Licence is attached at Appendix 1
- 1.3 The premises currently hold a Premises Licence at Appendix 2
- 1.4 This review has been instigated following the sale of alcohol to 16 year old volunteers during test purchase exercises carried out by the Trading Standards on the 2nd July 2011 and the 17th September 2011.

2. **RECOMMENDATIONS**

2.1 Members are asked to decide on this application having received written and oral evidence. The options include: -

Modify the conditions of the licence To exclude a licensable activity from the scope of the licence. To remove the Designated Premises Supervisor To suspend the licence for a period not exceeding three months To revoke the licence.

3. COMMENTARY

- 3.1 SUMMARY OF LICENSING LAW LICENSING ACT 2003.
- 3.2 The Licensing Act 2003 states that any premises in the London Borough of Bromley requires a licence / certificate issued by the Council (premises licence / club premises certificate) where the following activities occur:-

Provision of regulated entertainment

- a) plays.
- b) films.
- c) indoor sporting events.
- d) boxing or wrestling entertainment.
- e) live music.
- f) recorded music.
- g) performances of dance.
- h) anything of a similar description to that falling within (e), (f) or (g)

Provision of entertainment facilities for:

- i) making music.
- j) dancing

k) entertainment of a similar description to that falling within (i) or (j).

Provision of late night refreshment (between 2300hrs and 0500hrs).

Supply of alcohol (on and off sales).

The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

The sale by retail of alcohol by or on behalf of a club to a guest of a member of the club for consumption on the premises where the sale takes place.

- 3.3.1 Licences / Certificates may be issued subject to any terms, conditions or restrictions the Council feels are appropriate to address any or all of the four licensing objectives.
 - Licences / Certificates may be issued subject to any terms, conditions or restrictions the Council feels are appropriate to address any or all of the four licensing objectives.

This application is in respect of the protection of children from harm.

The premises is an independent buisness trading as Kwik Stop. The premises licence is held by Ashaq Hussain and Iftab Hussain. The Designated Premises Supervisor is Ashaq Hussain.

The premises was granted a licence on 14th January 2011 although according to Ashaq Hussain the shop did not start trading until April 2011. Mr Hussain has other shops in Peckham and Brixton.

HISTORY OF PREMISES

13th May 2011 intelligence received from Anti-social Behaviour Team concerning anti-social behaviour and sale of alcohol to under age youths from Stanley Way and Marion Crescent

25th May 2011 Trading Standards officers visit store and advise Maz Azam of complaints. A Challenge 25 pack is given together with advice about age restricted sales. Mr Azam told officers the boy who lives above the shop keeps wanting to buy cigarettes and he has refused him so the boys father brought him down to tell Maz to sell to the boy. Maz said he made it clear he was serving the father and not the boy. A tobacco notice was also left with the store.

It was later established that Maz Azam was in fact Maz Moshin.

23rd June 2011 further intelligence from Safer Neighbourhood Team alleging the offlicence in Stanley Way is selling alcohol to children. As a result of these allegations Kwik Stop was targeted for test purchasing.

On Saturday 2nd July 2011 Trading Standards conducted a test purchase operation resulting in the sale of tobacco and alcohol by Maz Moshin. When questioned by officers at the time he said he thought the volunteer was over 18. There was no refusal register and he said he worked there part time when asked by his friends father to cover for 2 or 3 hours per week. When questioned further he admitted working in the shop at least 10 hours a week, and later claimed he had once slept in the shop as no-one had come to take him home. He claimed to be a student studying Business and Marketing and was 22 years of age.

At the time of the sale Mr Moshin was using his mobile phone and he later admitted the sale was a mistake.

Mr Moshin later received a fixed penalty of £80.

On 11th August 2011 Mr Ashaq Hussain was interviewed under caution at the Civic Centre. Mr Hussain said Mr Moshin had worked for him for a few weeks and was a temporary arrangement while his own son was in prison. He described Moshin as his nephew.

Mr Hussain said his brother Iftab was working in the shop at the time of the sale but had stepped out to have a chat with the pizza seller round the corner as it was very quiet in the shop.

Mr Hussain went on to explain some of the problems he has had since opening the shop including being assualted by the neighbour who lives upstairs.

Training records are not kept although he was hoping to send Mr Moshin on a training course.

A copy of the transcript of this interview is attached.

A further test purchase was carried out on Saturday 17th September 2011. Mr Moshin was again working in the shop. The first volunteer was a girl aged 16 and she was refused a sale of cigarettes. Volunteer two was a 16 year old boy who was sold alcohol.

Although no officers witnessed the sale (both had been invovled in the earlier sale and so remained outside the shop) the volunteer told them the seller had said "No bloody ID same old story" referring to the attempt by the girl, adding "I have been done before and I don't want to get caught again - I take it you are over age" to which the volunteer replied "yes". No ID was asked for by the seller.

When interviewd at the time Mr Moshin said "I thought he was 22 or 23. He looked my age. I ID'd the girl as she looked young". When asked why he didn't ask for ID if he thought the boy was 22 or 23 he replied "I get fed up with abuse". When told the volunteer was sixteen and had been refused by 11 out of 13 shops that day he replied "He had a beard he looks older than 16".

Whilst in the shop officers witnessed a young girl aged about 14 come in and demand Mr Moshin sell her a lighter. When refused the girl screamed "Youre a f***ing liar" and walked out.

On the Thursday 6th October 2011 Trading Standards held a training day for small businesses in Bromley. The Fair Trade Award is administered by the Trading Standards Institute through local Trading Standards teams and is a recognised

accredited qualification. An exam is taken at the end of the session and results are compiled by the Institute. Mr Hussain sent three of his staff to attend the course, including Mr Maz Moshin.

The following conditions are for the panel to consider.

Refusals book or electronic point of sale refusals log - The Premises Licence Holder shall operate and maintain an up-to-date Register of Refusals of Sale of Alcohol, indicating the date, time and reason for refusal which shall be made available for inspection by the Trading Standards Department and Metropolitan Police. The DPS shall check the book once a week ensuring it is complete and up to date. The DPS will sign the book each time it is checked.

Training for all Staff, documented - A documented training scheme shall be introduced for all staff. The scheme shall be made available for inspection at the request of the Licensing Authority, Trading Standards and Metropolitan Police.

Or the premises licence holder shall ensure that all persons authorised to sell alcohol have completed a recognised underage sales training programme which includes a written test to verify the competency of that person

Staff training to be repeated at regular intervals - The Premises License Holder/DPS shall conduct [weekly] reviews with all members of staff and anyone else authorised to sell alcohol in order to reinforce the training and to promote best practice. A written record shall be made of the content of such reviews. [This record shall be circulated to all persons authorised to sell alcohol at the premises]

Records of staff training - The Premies Licence Holder [DPS] shall maintain a file that shall be available for inspection by the Police or officers authorised by Bromley Council at the shop premises for each person authorised to sell alcohol. The file shall contain all training records for that person and copies of the record of each of the weekly reviews

Records of staff selling alcohol - The Premises Licence Holder [DPS] shall maintain a file at the shop premises for each person at the premises authorised to sell alcohol. The file shall contain all training records for that person and copies of the record of each of the weekly reviews.

I am employed by the London Borough of Bromley as the Head of Trading Standards. I am an inspector of Weights and Measures appointed under section 72(1) of the Weights and Measures Act 1985 and hold the appointment of Chief Inspector of Weights and Measures as required by section 72(1)(a) of the 1985 Act. My duties include the enforcement of age restricted sales legislation including the Licensing Act 2003 and the Children and Young Persons Act 1933 as amended.

On 2nd July 2011 at 17:45 I sent a 16 year old male volunteer into Kwik Stop, 5 Stanley Way, Orpington, BR5 2HE. Shortly after the volunteer emerged from the premises with 1 packet of Mayfair cigarettes and 4 cans of Fosters lager.

I went to the shop with my colleague Tracey Firth, where I approached the seller, who gave his name as Mr Maz MOSHIN. He gave his date of birth as 7 March 1990 and his home address as 40a Camberwell New Road London. I cautioned him at 17.51.

He said "I thought he was over 18 and I was on the phone. I got it wrong".

On 11th August 2011 I interviewed one of the owners of the Kwik Stop, Ashaq Hussain. The interview was under caution and conducted at the Civic Centre. I produce a copy of the transcript in evidence.

On Saturday 17th September 2011 at 17:40 I sent a 15 year old female volunteer and a 16 year old male volunteer into Kwik Stop, 5 Stanley Way Orpington BR5 2HE. I waited outside. The girl returned having been refused the sale of tobacco. The boy returned with four cans of Tennants Super Strength lager. The volunteer told me the seller had said to him "No bloody id the same old story", referring to the refusal of cigarettes to the female volunteer. The seller had then said to him "I have been done before and I don't want to get caught again – I take it you are over age?" to which the volunteer had said "Yes".

I then entered the shop with my colleague Tracey Firth and I recognised the man behind the counter as the man who had previously sold alcohol to a volunteer on 2 July 2011. He was cautioned by Mrs Firth and asked why he sold to the alcohol and he replied "I thought he was 22/23. He looked my age. I ID'd the girl because she looked young. I said to the boy I been f****d twice and done over and I don't want this to happen again. I didn't ask for ID because I assumed he was old enough". I then asked why, if he thought he looked under 25, did he not ask for ID. He replied "I get fed up with the abuse". I informed him that we had been to 13 shops today and 11 had asked the volunteer for ID. Mr Azam said "he had a beard, he looks older than 16". I asked him how many hours he works at the shop. He replied "2 to 3 hours a day only at weekends. Look I made a mistake".

AH	Anything you question me and answer me, but on that occasion I was aware of
	it what happened, after, but as I wasn't there myself and I think Iftab had gone
	to pizza round corner to have a chat, because it's so quiet and boring in there,

AH	so he went down to pizza shop to have a chat to the pizza guys, just to have a



Application for the review of a premises licence - Kwik Stop, 5 Stanley Way, Orpington, BR5 2HE.

On 31st October 2011, Police received an application to review the premises licence for Kwik Stop, 5 Stanley Way, Orpington from Mr. Rob Vale, Head of Trading Standards for Bromley Borough Council.

By way of representation Police would like to add the following observations to that review.

Firstly, Police are very concerned that the sale of alcohol took place in July 2011 despite advice being given to the premises in May 2011. These area in which the store is situated suffers from disorder by youths. Much of that disorder is committed under the influence of alcohol.

The first offence of sale of alcohol is later compounded by the fact that in September 2011 a further test purchase was carried out at the store which was also failed.

This followed an interview at Bromley Council with the licence holder.


Secondly, Police are also concerned by the fact that the male spoken to in May and served with the advice pack gave his name as Maz Azam and following the sales in July and September gave his name as Maz Moshin. This appears to be a deliberate attempt in confusing the situation or to avoid prosecution and it is a fact that despite several attempts to contact Mr Moshin/Azam at the store to issue a fixed penalty notice for the sales he has never come forward.

It is quite clear from the information I have received that the premises is being run in a haphazard fashion with either no regard for the Licensing Act, 2003 or no understanding of what is required to comply with the Act or its objectives.

Either way, the poor running of the premises and the apparent disregard for the legislation is adding to the problems in the area of alcohol related crime and disorder and harm to children.

There is also some question as to the fitness of the staff employed by Mr. Hussain to deal correctly with alcohol sales, confrontation or indeed to apply the Law in respect of licensed premises.

In addition to those suggested conditions of Mr Vale, Police would add that 'there must be a minimum of two staff members in that part of the premises subject to the premises licence whenever sales of alcohol take place'.



I feel that this extra measure should assist staff in making the correct choice if faced with abusive or belligerent customers.

Police would like their views taken into consideration by The Licensing Sub Committee under the crime and disorder and protection of childrem from harm objectives.

I am writing to you on behalf of Bromley Safeguarding Children Board in response to your letter dated 19 October 2011 regarding the above premise.

We note, from the application for review of a premises license, that this establishment has sold tobacco and alcohol to underage young people during test purchase operations in July 2011 and again in September 2011.

Bromley Safeguarding Children Board is concerned about this as it contradicts the Be Healthy and Staying Safe objectives of the Every Child Matters agenda and the Board's Safeguarding Children procedure related to Licensed premises We therefore do not believe the licensee to be meeting the obligation to protect children from harm as laid out in Objective 4 of the Licensing Act 2003.

We would therefore like the concerns noted in this letter to be taken into consideration when reviewing this license. Additionally, we would recommend the license holder demonstrate that the child protection objectives of the application are addressed and that the premise adopts the London Safeguarding Children Board's procedure for Licensed Premises. <u>www.londonscb.gov.uk/procedures/supplementary_procedures/</u>.



1. BACKGROUND

1.1 Definition of Licensed Premises

A licence is needed for the:

- Sale/supply of alcohol
- Supply of gambling activities
- Provision of regulated entertainment
- Sale of hot food and drink to the public between 11pm and 5am.


1.2 The Licensing Act 2003

The Licensing Act 2003 was approved by Parliament in July 2003. The overall aim of the Act was to modernise the legislation governing the sale and supply of alcohol and public entertainment licensing. The Act has done this by transferring liquor licensing powers from the Magistrates' Courts to Local Authorities, via the creation of 'Licensing Authorities'. The current fixed hours when alcohol can be sold has also been removed so that licence applicants can request their own hours. 1.3 The Gambling Act 2005

The Gambling Act 2005 establishes a new system of licenses and permits for a wide range of gambling activities. The Gambling Commission was set up under the Act and has overall responsibility. It also has particular responsibility for the issuing of "Operator Licenses" to people who wish to provide gambling. Once a person has an operator licence they may then apply to the local council for a licence or permit to operate at specific premises. 1.4 Bromley's Licensing Authority

As a result of the Licensing Act 2003 and the Gambling Act 2005, The London Borough of Bromley is now the Licensing Authority responsible for granting premises licences, club premises certificates, temporary events notices and personal licences in the Borough, for the sale and/or supply of alcohol, the provision of regulated entertainment late night refreshment, granting premises licences for casinos, betting, bingo and adult gaming and family entertainment centre. Amongst other duties the Licensing Authority has to ensure that licensed premises are meeting four licensing objectives for the Licensing Act 2005:

- 1) The Prevention of Crime and Disorder
- 2) Public Safety
- 3) The Prevention of Public Nuisance
- 4) The Protection of Children from Harm

Licensing Objectives for the Gambling Act 2005


- 1. Preventing gambling being a source of crime or disorder, being associated with crime and disorder or being used to support crime.
- 2. Ensuring that gambling is conducted in a fair and open way
- 3. Protecting children and other vulnerable persons from being harmed or exploited by gambling.

1.5 Bromley Safeguarding Children Board as a 'Responsible Authority'

A number of specified 'responsible authorities' are notified of all licence variations and new applications. Responsible authorities include the police and fire brigade, as well as "a body which represents those who, in relation to any such area, are responsible for, or interested in, matters relating to the protection of children from harm, and is recognised by the licensing authority for that area for the purposes of this section as being competent to advise it on such matters". In Bromley it was agreed that it would be the Bromley Safeguarding Children Board. This means that we are able to make representations regarding licence variations and new applications, as well as being able to call for reviews of existing licences in light of the 4th licensing objective i.e. the protection of children from harm or exploitation.

As a result we have established a number of systems to ensure that we are meeting our responsibilities efficiently and effectively. One of which is on how to raise concerns about existing licensed premises and the processes that follow if the concern is substantiated. Ultimately, if concerns are brought to the BSCB's attention, then the

Board may call for a review of the licence and in turn make representations at an official committee hearing, which could lead to conditions being stipulated or even their licence being revoked.

The steps to be taken are outlined in a flowchart diagram on page 9. Please note that we use the term 'Children' to refer to all babies, children and teenagers up until their 18th birthday. The following section overleaf provides you with some background information about children's access to licensed premises and the potential risks to their welfare (this section has been taken from the Licensing Authorities' Policy for 2005-08).

Please can you acquaint yourself with sections 3 and 4 of this protocol, so that you are aware of what to do if you become concerned about the welfare of a child. If you have any enquiries please do not hesitate to contact the BSCB Office. Bromley Safeguarding Children Board: The BSCB Team 2. PREVENTION OF HARM TO CHILDREN

2.1 Access to Licensed Premises

The wide range of premises that require licensing under these Acts means that children can be expected to visit many of these, often on their own, for food and/or entertainment.

Where no relevant representations are received and an applicant volunteers prohibitions or restrictions in relation to the admission of children those will become conditions attached to the license.

Apart from the specific restrictions set out in the Licensing Act 2003 there is no presumption of permitting or refusing access to licensed premises. Each application and its circumstances will be considered on its own merits. The Licensing Authority will only seek to limit the access of children to licensed premises where it is necessary for the prevention of physical, moral or psychological harm.

With regard to Gambling, there are inherent restrictions within the Act limiting children from entering certain Gambling Establishments. Where children are permitted there have to be safeguards in place to prevent children being exposed to Gambling.

The Licensing Authority will consult with the Bromley Safeguarding Children Board and / or the Director of Social Services and Housing on any application that indicates there may be concerns over access for children.

The Licensing Authority will judge the merits of each application before deciding whether to impose conditions limiting the access of children. The following are examples of premises that will raise concern:

- Where entertainment or services of an adult or sexual nature are commonly provided
- Where there have been convictions of the current staff at the premises for serving alcohol to minors or with a reputation for underage drinking
- > A known association with drug taking or drug dealing
- > Where there is a strong element of gambling on the premises
- Where the supply of alcohol for consumption on the premises is the exclusive or primary purpose of the services provided at the premises

Examples of entertainment or services of an adult or sexual nature include topless bar staff, striptease, lap, table or pole dancing, performances involving feigned violence or horrific incidents, feigned or actual sexual acts or fetishism, or entertainment involving strong or offensive language.

The Licensing Authority will consider any of the following options when dealing with a license application where limiting the access of children is considered necessary to prevent harm to children:

- Limitations on the hours when children may be present
- Limitations on the presence of children under certain ages when particular specified activities are taking place

- > Limitations on the parts of premises to which children might be given access
- Limitations on ages below 18
- Limitations or exclusion when certain activities are taking place
- Requirements for an accompanying adult
- Full exclusion of people under 18 from the premises when any licensable activities are taking place

No conditions will be imposed requiring that children be admitted to any premises and, where no limitation is imposed, this will be left to the discretion of the individual licensee.

The Acts detail a number of offences designed to protect children in licensed premises and the Licensing Authority will work closely with the Police to ensure the appropriate enforcement of the law, especially relating to the sale and supply of alcohol to children and gambling.

Bromley Trading Standards have an agreed protocol with the Police for enforcing age related sales for alcohol sold for consumption off the premises and this will continue to be applied. The service will also undertake monitoring and test purchasing for compliance with other age related sales and services applicable to the Licensing Act 2003 e.g. cinemas.

2.2 The Portman Group Code of Practice on Naming Packaging and Promotion of Alcoholic Drinks

The Code seeks to ensure that alcoholic drinks are packaged and promoted in a socially responsible manner and only to those 18 and over. The Licensing Authority supports the use of the code as a means to promote the protection of children from harm and encourages retailers to follow it.

2.3 Children and Cinemas

Films cover a vast range of subjects, some of which deal with adult themes and/or contain, for example, strong language, scenes of horror, violence or a sexual nature that may be considered unsuitable for children within certain age groups.

Where an application for a Premises License or Club Premises Certificate includes the showing of films, the Licensing Authority will expect the operating schedule to include arrangements for restricting children from viewing age restricted films classified by the British Board of Film Classification or by the Licensing Authority itself.

All Premises Licenses and Club Premises Certificates granted for the exhibition of films will contain a condition restricting the admission of children either in accordance with the age classification by a film classification body under Section 4 of the Video Recordings Act 1984 or the Licensing Authorities recommendation.

It will be the Licensing Authorities policy to specify that the British Board of Film Classification will be stated on the license as the film classification body where a film has such a classification, however where there is no such classification or under such other circumstances as the Licensing Authority see fit its own classification may be imposed.

2.4 Children and Public Entertainment

Many children go to see and/or take part in an entertainment arranged especially for them, for example, children's film shows, discos and dance or drama school productions, and additional arrangements are required to safeguard them while at the premises.

Where an application for a Premises License or Club Premises Certificate includes the provision of entertainment for children or by children, the Licensing Authority will expect the Operating Schedule to include arrangements for protecting children.

The Licensing Authority will make full use of Licensing Conditions to secure the protection of children from harm. Conditions will be imposed where necessary, based on the individual application being considered and the Licensing Authority will have regard to the Model Pool of Conditions contained in the Guidance issued by the Secretary of State under Section 182 of the Act.

2.5 Children and Gambling

We have noted the Gambling Commission's Guidance for local authorities states that this objective means preventing children from taking part in gambling (as well as restriction of advertising so that gambling products are not aimed at or are, particularly attractive to children). We will therefore consider, as suggested in the Gambling Commission's Guidance, whether specific measures are required at particular premises, with regard to this licensing objective. Appropriate measures may include supervision of entrances/machines, segregation of areas etc.

This licensing authority will also make itself aware of the Codes of Practice, which the Gambling Commission issues as regards this licensing objective, in relation to specific premises such as casinos.

The licensing authority issued a Statement of Gambling Policy in November 2007 in which detailed information about the possible measures that could be considered to meet this licensing objective is set out in Part B.


2.6 Children Employed in Licensed Premises

Opportunities for young people to work in licensed premises are extremely limited. In accordance with the London Borough of Bromley Byelaws on the Employment of Children (1998), children under 16 may not sell or deliver alcohol and may not work in a commercial kitchen. However, occupations such as serving at or clearing of tables may be permitted in certain circumstances. Young people must obtain a work permit to work and will be required to abide by the legal restrictions concerning hours and times of employment.

Children and young people taking part in entertainment productions on any licenses premises may also be required to obtain an entertainment license.

1. SAFEGUARDING CHILDREN POLICY

1.1 Context

The protection of children from harm is a national licensing objective. The term 'children' refers to all babies, children and teenagers i.e. from birth till their 18th birthday. The words 'child protection' is included in the term safeguarding children.

This safeguarding children policy is for all staff (paid or unpaid) involved in premises which have been licensed under The Licensing Act 2003. This policy will give some basic information about what to do if you are concerned about a child and how your local Children's Social Services and Metropolitan Police Team will respond to and deal with reports about children whose welfare is causing concern. This guidance should be read in conjunction with the Licensing Act 2003.

1.2 Policy Responsibility

This Policy has been drawn up by the London Child Protection Committee in consultation with the London Area Child Protection Committees/Local Safeguarding Children Boards. Responsibility for revising the Policy rests with the Committee - your feedback on policy implementation will be welcomed.

1.3 Government Guidance


The Government position is that everyone working in an environment where there may be children present should safeguard and promote the wellbeing of children.

All adults (owner/license holders, staff and the wider community) must follow the Government Guidance published by the Department of Health (2002) "What To Do If You're Worried A Child is Being Abused". The Guidance describes the national framework within which local agencies and professionals should work and take action where there are concerns about the welfare of a child. A summary of the Guidance should be provided with this pack.

1.4 Training and Competence

All owners/license holders and their staff should have a basic awareness of Child Protection issues. This includes:

- Being alert to the possibility of child abuse and neglect, i.e. the definition, prevalence, identifying features in a child or adult, legal parameters and social consequences;
- Having enough knowledge to recognise an abusive or potentially abusive event or set of circumstances;
- Knowing who in the organization to raise your concerns with,
- Being competent in taking the appropriate immediate or emergency action, and
- Knowing how to make a referral to Social Services and/or the Police.

Information about this is included in this Child Protection Policy and in the "What To Do If ..." publication referred to in 1.3 above.

The licensee is responsible for ensuring that they and their staff are familiar with, and competent in following both this Safeguarding Children Policy and the Government Guidance.

1.5 Basic Principles

 If anyone involved with premises which have been licensed has any concerns about a child, then they must discuss these with the local Police Child Abuse Investigation Team and the local Children's Social Services at the earliest possible opportunity.

These may include concerns about a member of staff or a suspicion that an activity taking place in the establishment could place children at risk.

2) In any situation where there is a suspicion that there may be abuse the welfare needs of the child must come first (see Children Act 1989) even where there may be a conflict in interest e.g. where the suspected perpetrator may be a customer, client or employee/employer.

1.6 Protection for All

All children must be safeguarded from harm and exploitation whatever their:

- Race, religion, first language or ethnicity;
- Gender or sexuality;
- Age;
- Health, ill-health or disability;
- Location or placement (e.g. living alone in a hostel or residential unit, with their family or a foster family, as a tourist in an hotel etc);
- Criminal or offensive behaviour;
- Wealth or lack of it; and
- Political or immigration status.

2. DEFINITION OF CHILD ABUSE AND NEGLECT

2.1 Context

All the Local Authorities in London and the Metropolitan Police, use a single set of multi-agency procedures when working to safeguard children, these are the London Child Protection Procedures. The London Child Protection Procedures are also used all the other agencies in London who are in contact with children.

2.2 Child Abuse and Neglect

'Child abuse and neglect' is a generic term encompassing all maltreatment of children. Children may be abused or neglected through the infliction of harm, or through the failure of the adults around them to act to prevent harm.

The term 'child abuse and neglect' therefore includes the impact on children from serious physical and sexual assaults through to situations where the standard of care for the child

from their parent or carer does not adequately support the child's health or development.

Abuse and neglect can occur in a family or an institutional or community setting. The perpetrator of abuse may or may not be known to the child.

The Department of Health¹ has defines four broad categories of abuse which are used by professional working in child protection. These are: neglect, physical abuse, sexual abuse and emotional abuse. These categories overlap and an abused child usually suffers more than one type of abuse.

2.3 Physical Abuse

Physical abuse may take many forms, such as, hitting (including, with an object) or punching, shaking, throwing, poisoning, burning or scalding, drowning or suffocating a child or young person. It may also be caused when a parent or carer fabricates the symptoms of, or deliberately causes ill health to, a child or young person.

2.4 Emotional Abuse

Emotional abuse is the maltreatment of a child which has a severe and negative effect on the child's emotional development. It may involve conveying to a child or young person that they are worthless or unloved, inadequate, or valued only insofar as they meet the needs of another person. It may involve:

- Imposing expectations on a child or young person which are not appropriate for their age and/or development;
- Causing children or young people to frequently feel frightened or in danger e.g. witnessing domestic or other violence; and/or
- Exploitation or corruption of children or young people.

Some level of emotional abuse is involved in all types of maltreatment of children , though emotional abuse may occur alone.

2.5 Sexual Abuse

Sexual abuse involves forcing or enticing a child or young person to take part in sexual activities, whether or not the child is aware of what is happening. Sexual abuse includes penetrative (i.e. vaginal or anal rape or buggery) or non-

penetrative acts. Sexual abuse includes sexual exploitation of children through prostitution.

Sexual abuse also includes non-contact activities, such as involving children in looking at, or in the production of, pornographic materials, watching sexual activities, or encouraging children to behave in sexually inappropriate ways.

The fact that it is abusive to children to allow or coerce them into witnessing acts of a sexual nature between adults, **may be particularly relevant where children are exposed to adult focussed activities such as premises where sexual themes are prevalent**.

2.6 Neglect

Neglect involves the persistent failure to meet a child or young person's basic physical and /or psychological needs, likely to result in the serious impairment of the child or young person's health and development.

- This may involve failure to provide a child or young person with adequate food, shelter or clothing, failure to protect them from physical harm or danger or failure to ensure access to appropriate medical care or treatment. It may also include neglect of a child's basic emotional needs. This includes children or young people being present - with or without their parents, at venues unsuitable for their age e.g. venues with an 'adult only' activities such as;
- Events of a sexual nature;
- Where there are convictions of current members of staff for serving alcohol to minors;
- Premises where gambling is the main activity; and/or
- Premises where the supply of alcohol is the main activity.

Children need to be protected even when it appears that they are not aware that the physical abuse, sexual activity they are involved in or witness, or the neglect they experience, is harmful to them.

3. CHILD PROTECTION PROCEDURES TO BE FOLLOWED BY OWNER /LICENSE HOLDERS AND THEIR STAFF

3.1 Action to be Taken

Local Authority Children's Social Services, the Police (and the children's charity NSPCC) are the only agencies which have a legal obligation to investigate child abuse.

If you suspect that a child under the age of eighteen years or an unborn baby is being harmed by:

- Experiencing or already has, experienced abuse or neglect; and/or is
- Likely to suffer significant harm in the future;

You **must** talk to your nominated safeguarding children person and make a referral to your local Children's Social Services and your local Police.

3.3 What Children's Social Services and the Police will want to know:

When you contact the Duty Officer you should provide the following details:

- Your name;
- Your address and a telephone number at which you can be contacted in case they require other information or to follow up;
- The child or young person's name, and any other details, if known (parent's name, address, school etc);
- Relevant information about the circumstances of your concerns - what you see, hear or suspect to be happening about an individual child and young person;

• Also concerns relating to activities you see, hear or suspect to be happening about the premise or linked to the premises e.g. if you suspect that a member of staff is selling alcohol to young people who are underage or you believe that children are at risk of sexual exploitation (prostitution or internet pornography). You may not have all the details about a child or young person, or the activity but you should still refer.

You will be expected to put in writing within 48 hours the information which you have given verbally (telephone or face-to-face).

Children's Social Services and the Police should tell you how to respond to the situation in a way that supports their plan of action.

You may be in breach of your license if you do not disclose information where child abuse is suspected.

4.1 Nominated Safeguarding Children Person

Recommended best practice is for the owner/license holder to nominate themselves or a senior staff member to have the following responsibilities* in relation to safeguarding children for the licensed premises - to:

- Arrange safeguarding children training for all staff;
- Monitor and report on whether all staff have received the minimum (initial and refresher) safeguarding children training;
- Ensure that all staff have read and know where to find this policy and the Government Guidance: "What To Do If You're Worried a Child is Being Abused" (See 1.3 on page 1)
- Ensure that an up-to-date Safeguarding Children Procedures Poster is displayed for all staff at all times (See last page of this Policy);
- Provide advice and support to staff when they have a concern about safeguarding a child;
- Record all concerns raised by staff; and
- Be the contact person for the local Children's Social Services and the Police in relation to all incidents or concerns related to the safeguarding of children on or linked to the premises.
