3.3 Of all the applications made under the Licensing Act 2003 for a premises or club licence, 42% were referred to hearing by Licensing Sub-Committee The overall percentage of applications for premises/clubs granted was 98.7%. Only 1 (1.3%) were refused.

Premises Licences (New Licences , Variations and Reviews)

Officers determined 26 (57%) and 35 (43%) were referred to Licensing sub Committee of which 25 were heard (4 were withdrawn) and only 1 was refused.

Clubs

No applications for new Club Premises Certificates were received but 11 sought to vary their licence. 10 were granted by officers and Licensing Sub-Committee granted the other 1.

Personal Licence applications

Only 1 application out of 192 was refused following a Licensing Sub-Committee hearing.
