1. Reason for report

- 1.1 At its meeting on 26th November 2014 the Executive considered the attached report and recommended that Council adopts the proposed Local Council Tax Reduction Scheme for 2015/16. The scheme proposed replicates the 2014/15 scheme, except where minor variations are required due to legislative changes and annual upratings. The Executive recommended that the scheme be adopted, with the Leader requesting that consideration be given to investigating the implications for increasing the percentage of council tax that claimants had to pay themselves in future years.
- 1.2 The main elements of the scheme are:
 - Assessments for working-age claimants are based on 81% of the claimant's council tax liability. Therefore, working-age claimants have to pay a minimum of 19% of their council tax liability.
 - Assessments for claimants of pensionable age will have their entitlement calculated on 100% of their council tax liability.
 - A budget of £100k per annum is available for the awarding of additional assistance where exceptional hardship/circumstances are demonstrated.
- 1.3 The findings from the consultation exercise carried out between 5th September and 27th October 2014 are set out in <u>Appendix 1</u> and the recommended scheme is set out in <u>Appendix 2</u>. It should also be noted that the scheme attached at Appendix 2 will need revising to reflect the adoption date of the 2015 scheme and where appropriate 2014 replaced with 2015 and 2014/15 replaced with 2015/16.

2. RECOMMENDATION

Council is recommended to note the responses to the public consultation exercise and adopt the proposed Local Council Tax Reduction Scheme 2015/16.
