### 3. COMMENTARY

- 3.1 The Education Act 2002 and the Admissions Code 2012 (as Amended 2014), require that each year, the Council must formally determine its Admissions Arrangements for all schools for whom it is the Admissions Authority. Bromley Council is the Admissions Authority for Community and Voluntary Controlled schools: Bickley Primary School, Downe Primary School, Poverest Primary, St Pauls Cray Primary, Churchfields Primary School, Edgebury Primary School and Southborough Primary School. Once determined, the arrangements apply to all admissions into each of these schools.
- 3.2 For the 2019/20 academic year, the arrangements must be determined by 28<sup>th</sup> February 2018. This paper sets out the background to the proposed Admissions Arrangements 2019/20 for determination, which are set out in Appendix 1.
- 3.3 The Admissions Code of Practice also requires that there is a formal consultation on Admissions Arrangements at least once in every seven years. This year is the seventh year and the request for determination follows a period of consultation for which there were no responses.

# 3.4 Admissions Arrangements

- 3.5 As required by law, the arrangements comprise:
  - Age of admission
  - Application procedure
  - Oversubscription criteria
  - Offer of places
  - Late applications
  - Waiting lists
  - Transfer from Infant to Junior schools
  - In-year applications
  - Appeals
  - Children with Education Health and Care Plans.
- 3.6 The proposed arrangements are the same as those which have been in place for a number of years. Admissions Appeals and challenges to Admissions Arrangements in Bromley are generally very low and last education year, consistent with the pattern of previous years, only five Appeals were heard between all of the seven schools listed above, none of which were upheld. The combined factors of low numbers of Admissions Appeals and no responses to the Consultation for proposed Arrangements suggests that determination of the Arrangements (at Appendix 1) holds a very low risk.

#### 3.7 Consultation

3.8. The Consultation ran between 18<sup>th</sup> December 2017 and Monday 29<sup>th</sup> January 2018, with notifications in the local press, on the Council website and in the Schools Circular. There were no responses.

# 3.9 What happens next?

3.10 Following the Council's determination of the proposed Arrangements, these Arrangements and any others for *new* Admissions Authorities within Bromley must be published on the Council Website by 1<sup>st</sup> May 2018. As there are no new schools, the latter requirement does not apply. The website must also provide the details of where the determined admission arrangements for *existing* schools in Bromley can be viewed. Lastly the website must provide details of how objections to the arrangements are raised and determined.
