# 3. COMMENTARY

- 3.1 The scheme of delegation has recently been significantly revised (at General Purposes and Licensing Committee in April 2022) to make it more effective and concise. Following this update several minor tweaks are required to the powers delegated to the Director of Housing, Planning and Regeneration to ensure that the scheme is as effective as possible and to restore powers that were mistakenly removed in the recent revisions. The requested changes are to restore powers as follows:
- 3.2 Power to refuse any application:

The previous scheme of delegation included the power to refuse any application (unless subject to call in).

3.3 Power to determine amendments to major applications for new commercial development and for the provision of twenty one or more dwellings:

The previous scheme of delegation included the power to determine applications which fall within the definition of major development as above but comprise "other associated buildings, conversions, extensions and change of use, reserved matters, details pursuant, revised plans or amended proposals"

3.4 These two elements were included in the previous scheme of delegation and removed accidentally from the revisions and thus do not represent a change from long standing powers held in respect of planning applications.
