(ii) CHIEF OFFICER DISCIPLINARY PANEL

Chief Officer Disciplinary Panels for Chief and Deputy Chief Officer posts should compose nine Members as follows: the Leader of the Council, a majority Party Member of the Executive, a majority Party PDS Chairman, two Labour Members, one Liberal Democrat Member, one Chislehurst Matters Member and two Members from the following choices:

Either the Chairman of the General Purposes and Licensing Committee, the Vice-Chairman of the General Purposes and Licensing Committee, a second Majority Party Member of the Executive or a second Majority Party Member PDS Chairman.

(iii) CHIEF EXECUTIVE ANNUAL REVIEW PANEL

The Chief Executive Remuneration Panel should compose nine Members as follows: the Leader of the Council, the Deputy Leader of the Council, the Resources, Commissioning and Contracts Portfolio Holder, the Leaders of the Labour, Liberal Democrat, Chislehurst Matters Groups (or their nominees), one other Labour Member and up to two other Majority Party Members.
