### 1. Reason for decision/report and options

This report seeks approval to make pedestrian and cycle safety improvements at the roundabout of South Eden Park Road / Links Way / Monks Orchard Road Roundabout. The proposals (as outlined in section 3) are aimed at reducing the number of collisions at this location and provide a safer environment for all road users.

A study was carried out to identify junctions which presented an increased risk to road users. As a result of this, the roundabout in this report had been selected for further study and development to address the issues/risks presented.

# 2. RECOMMENDATION(S)

That the Portfolio holder approves the following:

- 2.1 Junction improvements at the roundabout of South Eden Park Road / Links Way / Monks Orchard Road, as detailed in section 3 of this report.
- 2.2 Any minor changes to the design to be delegated to the Director of Environment and Public Protection, in consultation with the portfolio holder.

### 3. COMMENTARY

- 3.1 The junction of South Eden Park Road / Links Way / Monks Orchard Road is an important link which facilitates the connections to/from West Wickham, Elmers End and Beckenham. The junction is in proximity to four schools, a sports centre, Bethlem Royal Hospital and Eden Park station.
- 3.2 As was set out in the report to this committee in June this year (Comprehensive Review of Road Safety in LB. Bromley), the Council is focussed on delivering a targeted and cost-effective casualty reduction programme in the Borough. One location that unfortunately features on our list is the junction of South Eden Park Road / Links Way / Monks Orchard Road.
- 3.3 This location is on the Council's list of 34 "cluster" sites with high number of collisions. This roundabout was found to have had 8 collisions in the 3 years that were studied. In the last 3 years, data still shows 7 collisions which means the situation has not improved. The majority of these collisions involved cyclists.
- 3.4 Officer site visit observations suggested the current junction is vehicular dominant and there is a lack of dedicated provision for pedestrians. The proposals include interventions to slow traffic coming towards the roundabout to reduce rear end shunt collisions. Also, officers are proposing formal crossing points for pedestrians to encourage walking which is currently a barrier for more vulnerable residents plus off-carriageway crossings for cyclists and narrower carriageway widths to minimise the crossing distance for pedestrians, whilst still allowing adequate provision for larger vehicles to use the roundabout.

# 3.5 Proposals:

The following changes are being proposed for the junction:

- 1. Widening of footways on all arms of the roundabout and narrowing lane widths to slow down traffic and improve deflection at the roundabout.
- 2. New shared spaces for both pedestrians and cyclists; this will allow cyclists to manoeuvre around the roundabout safely.
- 3. Introduction of parallel zebra crossings on all arms of the roundabout; the purpose of this crossing is to allow priority for pedestrians and make them more visible to drivers.

# 3.6 First Year Rate of Return (FYRR)

The target collision savings at this roundabout is estimated at 45% due to combined safety measures to slow down traffic and provide formal crossings for pedestrians and cyclists. This brought the FYRR figure to 78%.
