**(ii) CHIEF OFFICER DISCIPLINARY PANEL**

That Chief Officer Disciplinary Panels for Chief and Deputy Chief Officer posts should compose nine Members as follows; the Leader of the Council, a majority Party Member of the Executive, a majority Party PDS Chairman, one Labour Member, one Liberal Democrat Member, one Chislehurst Matters Member and two Members from the following choices:

Either the Chairman of the General Purposes and Licensing Committee, the Vice-Chairman of the General Purposes and Licensing Committee, a second Majority Party Member of the Executive or a second Majority Party PDS Chairman.

**(iii) CHIEF EXECUTIVE ANNUAL REVIEW PANEL**

That the Chief Executive Annual Review Panel should compose nine Members as follows; the Leader of the Council, the Deputy Leader of the Council, the Resources, Commissioning and Contract Management Portfolio Holder, the Leaders of the Labour, Liberal Democrat and Chislehurst Matters Groups (or their nominees) and up to three other Majority Party Members.
