- 3.1 In accordance with the Scheme sealed by the Charity Commission on 24th January 1997, the Council appoints six Nominative Trustees to serve on the Beckenham Parochial Charity Trust, each for a four-year term of office. The terms of office of three of the Trustees, Councillor Russell Mellor, Mrs M Jessiman and Mr A M Wilkinson, expired on 24th January 2011. Mrs Jessiman and Mr Wilkinson have both been trustees since before the trust was established in its current form in 1997, while Councillor Mellor was first appointed in 2001. The Secretary to the charity has confirmed that all three wish to be re-appointed for a further four-year term.
- 3.2 The work of the Trustees includes attendance at quarterly evening meetings of the Trust held at St.George's Church, Beckenham and serving on one sub-committee of the Trust which meets to determine grant applications. The Committee is, therefore, requested to consider the re-appointment of the three Nominative Trustees as indicated above each for a four-year term of office expiring 24th January 2015.
