# 1. Reason for report

1.1 This report seeks Council approval to some minor amendments to the Council's Constitution following changes to officer titles and responsibilities. The report also seeks approval for these changes to be reflected in the Scheme of Delegation to Officers, pending a full review of the Scheme for the Council's annual meeting.

#### 2. RECOMMENDATIONS

- (1) That Council approves the minor amendments to the Council Constitution set out in Appendix 1 relating to (i) the new officer titles of Director Resources and Finance Director, and (ii) various other minor corrections.
- (2) That, pending a full review at the next annual meeting of the Council, all references to the title of "Director of Legal, Democratic and Customer Services" in the Council's Scheme of Delegation to Officers be replaced by "Director of Resources," and any delegations relating to the role of the Section 151 officer be taken to refer to the Finance Director.

- 3.1 As of 11<sup>th</sup> April 2011, the former Resources and Legal, Democratic and Customer Services Departments will become a single Resources Department. Mark Bowen will become the Director of Resources, and Peter Turner will become the Council's Finance Director, holding the Section 151 responsibilities as chief finance officer. In addition, at the Council meeting on 28<sup>th</sup> February 2011, it was agreed that Sheila Bennett would be the Council's statutory Scrutiny Officer. As a consequence of these changes, it is necessary to make some minor amendments to the Council's Constitution to ensure that it is kept up to date. The opportunity has also been taken to identify some minor errors in the text which can be corrected.
- 3.2 <u>Appendix 1</u> contains a schedule of proposed changes. These are all related to changes in officer designations or correction of minor errors in the text. No material changes to the Constitution are proposed.
